Last month I closed my ruminations by encouraging you to "enjoy all the sunshine, warmth, community festivals, and county fairs that August has to offer, [praying also] that you look for God at work in the world around you." The last month and its mild temperatures have offered us frequent reminders of God's continued creation and blessing upon this beautiful area of our world. I hope that you have taken time to pause and just be still, feeling the peace that Christ offers to your life and not running yourself ragged to "enjoy" summer vacation!?!

In July and August, I enjoyed the opportunity of extra physical exertion on behalf of this congregation. In July, Eric Johnson, Staci Thompson, Kevin Benson, and I represented Habitat for Humanity of Martin and Faribault Counties on the Habitat 500 fundraiser bicycle tour in northern Minnesota. While Kevin had the misfortune of experiencing heart issues after the first day and ended up

having triple-bypass surgery right in Duluth, he is recovering quickly and we pray that his determination will see him back and better than ever for the 2020 Habitat 500. The rest of us continued the ride with him constantly in our thoughts and prayers. I had the opportunity to meet several other pastors on the ride, which affirmed for me the importance of our congregation's continued support for such a valuable ministry of physical exertion, on-site construction work, and continued financial investment. We enjoyed getting to see a pair of Habitat homes in progress, while Staci and several of the riders took a day "off" the road to pitch in on some of the construction work.



In August, Eric Johnson (apparently a glutton for punishment much like myself) led another very



successful "Adventure Crew" trip, this time to the beautiful North Shore of Lake Superior and the Superior Hiking Trail. We had 13 total participants (the biggest group to date), including four friends from outside our congregation who got to experience what a great Christian family is like in action. We hiked further than many thought they could, slept in tents, ate "camp" foods, jumped into rivers, kayaked, played games, and had devotions in beautiful surroundings and mostly good weather. Jon Neitzel and Eric did an excellent job planning, leading, and cooking for this motley bunch of adventurers, and a great time in God's creation was had by all!

As September now looms and children prepare to return to school, please pray for their continued success and safety in our area school districts. The calendar change also means that worship services will be moving back to 10:30 after Labor Day (starting September 8), and Sunday School opportunities for "children of all ages" will soon begin at 9:15 on Sunday mornings.

Watch for more information in your mailbox if you have a child in the congregation, but remember that EVERYONE is invited to be a part of some form of Christian education at First Congregational UCC. Being a Christian doesn't just mean showing up regularly for worship services; it's a life-long learning and growth process that can be both challenging and fun! Two-thirds of the offering is used by the UCC's Justice and Witness Ministries to fund a wide array of local and national justice initiatives, advocacy efforts, and direct service projects. Through ucc.org/justice, our national Justice and Witness Ministries office offers resources, news updates, and action alerts on a broad spectrum of justice issues. Working with members of the UCC Justice and Peace Action Network (a network of thousands of UCC justice and peace advocates), Justice and Witness continues its strong policy advocacy work on issues such as the federal budget, voting rights, immigration, health care, hate crimes, civil liberties, and environmental justice.

Fareway and Hy-Vee Receipts Report as of 25 August 2019





Letter to Church Newsletter Rev. Cory Germain Ann Osborn 319 Downtown Plaza Fairmont, MN 56031

Early this afternoon I spoke to several local News Media regarding a disturbing phone call we received about our grandchild crying and asking for our help to get the grandchild out of jail. We asked if this was our grandchild's "name". The answer was yes and went on to say that only one phone call was allowed. We were instructed to bring \$2,000 right away so the child could be released. We asked if we could come to the jail and talk to the arresting officer.

We were told it was either "Mr." Brooks or "Mr." Green. "Officer" Green answered and said our grandchild was under a gag order and had only one phone call and ours was the one call. He said he was from the State Police. I asked for his badge number--which he gave. He said he was *not* the arresting officer.

We said we would come to the jail and he said "No, we do not have a cash box here. You will have to go through the 'Bail' Dept." We asked for details of the arrest. He said our grandchild was with a friend in a car that neither one owned. The friend blew through a stop sign so the officer stopped them this morning. There were drugs in the vehicle. Then he told us the amount of bail was \$4,000. We told him we did not have that kind of money readily available. He said to go to the bank and get a "cash advance". I pushed for more details of the arrest and he said he was not the arresting "Officer" from the State so he would have to get the details while putting us on"hold".

In the meantime while I was on the phone waiting, my husband phoned our grandchild at work and talked to our grandchild. By then, I was disconnected from the "hold" call. I quickly called the Martin County Law Enforcement Center and notified them of the call. They said it was a SCAM and not to follow through. She also said to tell our friends and relatives about this miserable phone scam.

These two people were very pushy. The "grandchild" was crying and asking for help from us right away. The "Officer" became very brusque and insistent. We thought it was strange the officers were identified as "Mr." and the child's voice didn't sound quite right. Another red flag was the amount of bail increasing from \$2,000 up to \$4,000.
