#### **CERTIFICATION REQUIREMENTS:**

- 1. Engineer in Training Certificate (CBE-IT):
  - **a.** \*Documentation/Letterhead as an individual working in the Building/Facility trade. **This** certification is issued to all paid members after application is completed.
- 2. Apprentice Certificate (CBE-A):
  - a. \*\*Documentation/Letterhead as an individual in the Building/Facility trade with at least 2 years in the trade
  - **b.** Participation in educational training or OTJ training that is relevant to the Building Engineer trade and/or a letter or statement from supervisor attesting your training and qualifications for this designation level. **This certification is available to all members.**
  - c. Completion of two (2) First Thursday Trainings and or Building Tours.

#### 3. Journeyman Certificate (CBE-J):

#### This certification is available to members' that have been active for a total of 3 years.

- a. Documented four (4) years minimum experience as a Building Engineer \*/\*\*, and,
- b. Documented proficiency\*\*\* by an institution of higher learning or manufacture in at least three (3) of the following areas:
  - i. HVAC I & II/Refrigeration Systems and accessories
  - ii. Air Handling, Water Treatment, and Plumbing
  - iii. Electricity I & II/Electrical Systems and Illumination
  - iv. Boilers, heating and applied mathematics
  - v. Energy Management Controls / Building Automation Systems
  - vi. Administration
  - vii. Building Design and Maintenance
  - viii. Environmental Health and Safety Issues
- c. And or four (4) years of OTJ training with Contractors, Manufactures, and Engineering/Facility Managers. Please list years of experience with each of the above and equipment type.
- d. (Examples) 5 years with/Chief Engineer on Trane RTUs
  - 4 years with/ Facility Manager on York Chillers
  - 3 years with/ Manufacture on Johnson Controls
- E. Must include a letter of recommendation from one of the above

#### 4. Master Certificate (CBE-M):

#### This certification is available to members' that have been active for a total of 6 years.

- a. Completion of "all" journeyman requirements/courses above, documented six (6) years' experience as a Building Engineer, with two (2) years as a Chief/Senior Engineer\*\*.
- b. Documented proficiency\*\*\* by an institution of higher learning or manufacture in four
   (4) areas above, plus at least two (2) of the following areas below are mandatory.
   Completion of "all the following" may be substituted for the two (2) year Chief/Senior requirement:
  - i. Property Condition Assessments
  - ii. Design, Operation, and Maintenance of Building Systems I & II
  - iii. Ethics
  - iv. Managing the Organization

\* Or equivalent title used within the Building/Facility industry.

\*\* Or equivalent position in the industry with duties/responsibilities thereof.

\*\*\* Advanced demonstrated proficiency may be considered in lieu of documented proficiency by providing below indicating equipment, types, principle, operation, maintenance, and experience, and or Any projects or contracts you have overseen or performed like special projects and/or supervised construction/finish-out projects with the General Contractors letter head statement with contact information for verification of personal knowledge of your performance and understanding that trade(s) for each item/field in 3 (b) or 4(b).
