Zoning Officer Report: There was a ZBA meeting on October 10/20/2020 for an Area Variance for Mark Ramsey, building on Buffalo Road. The variance was given.

<u>Highway Superintendent Report:</u> The Centerline Hill project is complete, the guard rails are up – went another 100 feet. We have been mowing banks, and working on the trucks. We had to sand on Monday! We purchased two sets of tires for 205 and 20 (16 Tires - \$4,100) Working on our Covid policy with the Town Clerk.

<u>Town Clerk Report:</u> Our Town website visits for October was 1582. The Towns total revenue for the month of October 2020 was \$479.00, \$105.00 for Zoning, \$324.00 for dog licenses, DEC - \$30.00 and Scrap License \$25.00 and Late Fees - \$5.00. We had 21 dog renewal licenses and 4 new license. To the general fund, \$246.11, Dogs were 110.00, \$5.00 late fees, \$1.11-DEC, \$105.00 for Zoning, \$25.00 for a Scrap license. Sent \$44.00 to Ag and Markets for dogs, \$170.00 to Wyoming County Treasurer and \$18.89 to DEC.

Supervisor May requested a motion for another resolution for the Court Grant. The NY Courts, Kathleen Roberts has requested that the resolution must contain certain verbiage. Mr. J. Ahl made a motion to resolve that the Town of Orangeville authorizes the Orangeville Town Court to apply for a JCAP grant in the 2020-2021 grant cycle up to \$30,000.00, this motion was seconded by Mr. J.
