- b) RV Camping We have a couple that has been camping at the fairgrounds for 7 to 9 years and the increased rate to \$25 a night was more than they were expecting. After discussion the board agreed to reduce the 2016 rate to \$840. In 2017 if they are in the new spots, there will not be a discount, they will have to pay the 2017 rate.
- c) 2017 Do's and Don'ts to bring to the fair the San Diego list was discussed and changes were made but the main change will be there will not be any smoking inside the gates for guests, staff and security.
