NOTICE TO EXHIBITORS:

ENTRIES NOT ON OFFICIAL AKC ENTRY FORMS OR PHOTOCOPIES OF ENTRY FORMS without the Agreement and Rules on the reverse side of the Official AKC Entry Forms are **NOT ACCEPTABLE**. Unsigned entries or entries with missing information other than the dog's call name will be returned. **TELEPHONE, FAXED, INCOMPLETE AND UNSIGNED ENTRIES** cannot be accepted.

ERRORS ON ENTRY BLANKS: Owners are responsible for errors in making out entry forms, and no entry fee will be refunded in event of such errors or cancellation of entries after trial has closed.

ENTRIES RECEIVED WITHOUT FEES will not be accepted.

Fees: Pre-Entry Fees are \$20 for each titling class; \$15 for Introduction to Quarry. Day of entries are \$20 for each titling class and \$15 for IQ. EE entry fees are \$35 pre-entry and \$35 day of entry. Please make checks payable to "CATC". **All funds submitted must be in US currency.**

RETURNED CHECKS do not constitute a valid entry fee. A charge of no less than \$25.00 will be made for each returned check.

NO ENTRY SHALL BE MADE AND NO ENTRY SHALL BE ACCEPTED, WHICH SPECIFIES ANY CONDITIONS AS TO ITS ACCEPTANCE: Express mail entries must include signature permitting them to be left at the secretary's address without the recipient's signature.

ENTRY FEES SHALL NOT BE REFUNDED in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of Trial Committee. If because of extreme weather, riots, civil disturbances or other acts beyond the control of the management, it is impossible to open or to complete the test, no refund of entry fees will be made.

JUDGES ARE NOT REQUIRED TO WAIT FOR DOGS. The owner of each dog is solely responsible for having it ready when it is to be judged. The club has no responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not in the holding area when required. If handlers have a ring conflict and so inform the gate steward, every effort will be made to accommodate them.

TEST COMMITTEE WILL NOT BE RESPONSIBLE for nor will it assume any liability in the event of an accident or misfortune to either dogs or exhibitors participating in this show.

BITCHES IN SEASON are not allowed on the trial site.
