You will also have to submit a copy of the Eligible Veteran DD214 or Proof of Eligibility.

Along with the membership form, you will need:

- A copy of the DD214 (F NOT POST AFFILIATED (Certificate of release or Discharge from Active Duty)
  attached to the membership form. If you need a copy of the DD214, you can go online to:

  - \*Continuous member (pays dues yearly) \$25 + \$10 Adm. Fee (1 time only) = \$35.
