VOTING PROCEDURE

Area business meetings will, at the discretion of the area chairperson, follow modified Robert's Rules of Order, as follows:

A motion is made:

- If it does not receive a second, it dies. After a second, debate is opened*.
- If a registered voter calls for the question, a second will be required, or debate resumes.
 - A Question must be called **in turn** at the microphone (i.e. an individual cannot speak on the motion and then call the guestion).
 - If the Question is seconded, a 2/3 majority will end the debate, or debate resumes.
 - If the Question is not called, debate will go on until there is no one at the microphone.
 - Once debate ends, a sense of the group will be taken by **simple majority to vote or table** (urgent or administrative)**.

A motion is voted on:

- If it involves expenditure of Area funds, the finance committee will be asked to report.
- It requires a 2/3 majority to pass.
- The "non-prevailing" side will be asked if they wish to speak to their position as a **minority opinion** (if there is no minority opinion, the voting result will stand).
- If someone speaks for the minority, the "prevailing" side will be asked if there is a motion to revote, and it requires a second.
- A simple majority is required to revote.

A motion is reconsidered:

- Full debate pro and con is resumed (please limit discussion to only new considerations).
- The question may again be called and seconded, and requires a 2/3 majority to end debate.
- A sense of the meeting may be taken by simple majority to vote or table.
- If voted on, the motion must have a 2/3 majority to pass.

Debate has ended. Debate on a tabled motion will be resumed under old business at the next Assembly, and the voting process will be the same as above.

*Discussion may be entered into only by voting members. A non-voting member may offer a point of information if recognized by the Chair.

**If a motion is deemed urgent or administrative we will vote upon it today. If not urgent or administrative the motion will be tabled and taken back to your groups for discussion. The motion will then be voted upon in Old Business at the next assembly. Minority voice is not heard on Tabling a Motion, Calling the Question, or Motion to Reconsider a Vote.

New Business

Item #1 - Increase Area Chair Budget

Submitted by Jim F., Alternate Delegate

Motion: Increase the 2017 Area Chair's budget committee line item from \$5,000 to \$5,975.

Intent/Purpose: Due to my home location, there was additional mileage. Due to an entry error in Finance, this error was not identified in a timely manner. Finance has initiated steps to ensure this situation does not occur. At every assembly, all members submitting expense reports will receive an up to date account balance and a status of whether their balance is positive or negative.

Current Practice: 2017 Area Chair budget is \$5,000 for the year.

Budgetary Impact: \$975

Seconded by Bruce L., District 21 DCM

Randy W., Finance Chair, indicated that the Area can afford the expense

Randy W., Finance Chair: Hi, I'm Randy, I'm an alcoholic. I am now your current Finance Chair. A couple of things I want to address with this. Yes, there was a mistake in Finance. It was a entry error because of the spreadsheet that we have. This spreadsheet has been passed down from committee to committee for the last 10-12 years. If anyone has ever worked with Excel, you will know that if the proper safeguards aren't installed, that formulas can be changed, references can be changed, a lot of things happen. This is essentially what has happened. What we have done in finance is we've made these policy changes. Whenever someone comes in to do their expenditures, before they leave our table, they will have the remaining budget balance available to them. They will also have, if they've taken draws, the amount of money that they owe, or we owe them, before they even leave. A procedural change: prior to the end of an assembly, every person that receives money for expenditures will have a copy of

their balance sheet, telling them exactly what they have and don't have. We've also done some infrastructure changes as far as the security of the spreadsheet. One, for the past couple of months, I've been working quite diligently on getting the security back into that spreadsheet, so that when it goes from person to person, unless they have the password, they can't change a formula, they can't change a reference. Those security procedures have been enacted.

Motion determined by a majority to be urgent and/or administrative and will be voted on immediately. Vote taken on the motion, **Motion PASSED** unanimously.

Item #2 - Increase Regional Travel Budget

Submitted by John A., Area Treasurer

Motion: Increase the regional travel line item in the 2018 budget from \$6,330 to \$10,000.

Intent/Purpose: Finance committee is requesting an increase due to the addition of the Regional Forum being held in San Jose, CA. This event occurs every other year and in 2018 is the year for the Regional Forum.

Current Practice: 2018 regional line item is \$6,330.

Budgetary Impact: Increase of the 2018 budget by \$3,670.

Seconded by Casey, District 17

Randy W., Finance Chair, indicated that the Area can afford the expense

Casey: I was wondering, how many people do we send to that Region Forum?

Ron W: Four of us. The Chair, the Alternate Chair, the Alternate Delegate, and the Delegate. The expenses include their flight, their hotel, their registration, all their expenditures at the event.

Casey: So it's a travel budget for 4 people?

Ron W.: Yes

Casey: Thank you!

Darla B., District 5: I'm wondering, so this is to increase it due to a convention that's held every other year, so are you going to revert it back next year? Or is this going to be a continual increase? **Ron W.**: It will revert back next year.

BJ, **GSR Johns Landing Group**, **District 36**: I would like further information written into this, because it doesn't say for travel ... I would just like it written a little bit more clearly because that's a huge jump. I get that it's for 4 people but \$10,000 is a lot of money and it doesn't really outline what exactly it's for and I feel like we need a little more information in the motion itself. It doesn't seem unreasonable, but a little bit more information would be helpful.

Brandon, District 26: I just was hoping to get a little clarification on this. We already have a budget and so that seems like there's already a regional forum. But the motion seems to suggest that we're adding a regional forum, but we already have a budget for it. So I'm wondering if this regional forum is in addition to an existing regional forum, and so we're doing two regional forums, or if this one is more expensive for some reason? I'm just confused, thanks.

Riley, Past-Delegate: Let me clarify this, I'm the one who discovered this error and brought it to the attention of the finance committee so they could make this motion. In the year before last, when the regional forum was held in Hawaii, additional funds were added for the increase in expenses to go to Hawaii, and the budget was twelve thousand something, and we passed that. Then with no regional forum the next year, then the budget was cut in half, it went back to covering the PRAASA and the PNC. This year when the budget was formulated, I neglected to notice and bring it to the attention in a timely manner that it was just carried across from last year and that the additional money for the Regional Forum was not included this year. It doesn't have to go back to the twelve thousand because we don't have the increase for Hawaii added in there. So going up to ten thousand would bring it back to our normal travel budget for our normal 3 events every other year.

Brian, DCM District 6: As others have said, I too am a little confused by... The way the motion reads, is that an increase for the regional line item of the budget, but it doesn't say for what exactly. And secondly, if this is indeed just for the Regional Forum, just as an example, I as a DCM am asking for \$500 for my area to send me to that. I'm not sure what line items this is being spend it, it just seems exorbitant to my sensibilities.

Randy W., Finance Chair: Just to clarify something, I did see a mistake. In my motion, it says Regional Travel line item. On the budget, if you look at your Treasurer report, there is a line item labeled Regional Travel. That Regional Travel line item is the line item, or the budget item, that we use for travel for the four individuals from Area to those three different events. That's why it's a large amount of money, it's travel to three different locations throughout the year for 4 people.

[inaudible name], District 27: I think that pretty much answered it, it's for 4 different people to multiple regional events and for a whole year. So that explains how \$10,000, it easily could add up to that. My only question is, and I think this is with the other line items for travel for anybody, is it that anything that is unused gets returned? I'm just curious if that for some reason they didn't spend their \$2,500 each, or whatever it ended up being, does it go back into the Area.

Randy W.: Yes it does. If the money is not used...that goes for any line item on our budget, is it remains in Area's account. And also, just a little further explanation, this includes airfare, driving costs, lodging, that usually a pretty big cost, and meals, we allot up to \$25 a day per diem for meals. It's a full breakdown of their travels, so they don't have to incur the costs themselves, and we as Area provide them to go to these events for our purposes.

Nick: I think a lot of this was already said. I think it's important that our elected members go. I know I'd like to see everybody go that wants to go, but I think it's important that if they're going to represent us as an Area, also to highlight kind of what he was saying, that there's also a surplus in other areas that we didn't use, committees to assemblies, DCMs to assemblies, Delegate's budget. I think it's important to remember that we're not really here to carry a balance but to carry the message. That's what I have to say, thank you.

David, DCM District 14: Reilly was saying they increased it to go to Hawaii to \$12,000. She said it was cut in half and it's now \$6,330. Would this pretty much be just putting it back to originally what it was in 2016, before it was increased and then cut in half? **Randy W.**: Yes.

Question was called by Bill W., Proxy MCCF Down But Not Out Group Vote taken to end debate, 2/3 majority achieved. **Debate Ends.** Vote taken on the motion. 2/3 majority achieved. **Motion PASSES.**

Minority Opinion

Brian, DCM District 6: I just personally don't feel comfortable with that amount without seeing what it is the trusted servants are going to be spending \$10,000 on. Personally, and this just me being fiscally responsible with the fellowship's money, would like to see what it is that \$10,000 is going for. I personally come to the assemblies and I don't charge my district for food because I would eat anyway, and that's just me.

With no motion to re-vote, the motion stands as PASSED.

Item #3 – Treatment Facilities Pamphlet - WITHDRAWN

Submitted by Scott F., DCM District 18 (dcm18@aa-oregon.org)

Motion: To create a pamphlet or booklet that serves to orientate individuals in treatment centers and to offer suggestions and distinct directions toward how to maximize success in treatment.

Intent/Purpose: There is no pamphlet available that speaks to these issues

Current Practice: Bridging the Gap, Do You Think You're Different?, Where Do I Go From Here, AA in Treatment Settings, create a hodge lodge band aide effect

Budgetary Impact: Unknown printing costs.

Seconded by Casey, District 22

Rose, Registrar District 4: Would this funding, that they don't have the total for, come out of World Services or the New York budget? Rather than Oregon Area 58's budget?

Scott F.: The question was where the funds would come from to generate this and our belief would be that it would come out of GSO. It wouldn't be just specifically for Area 58.

Casey, GSR District 14: What are the contents going to be, of the pamphlet. Is there a prototype out there? I guess I just want to see what's in the contents, besides what's already in our Big Book and the literature that's out there, that's going to be new.

Scott F.: The prototype that I referred to at the beginning was "It Sure Beats Sitting in a Cell" which is for corrections. It wouldn't take [much] to modify this pamphlet to serve the treatment issues. They give the preamble, they walk everybody through. They set them up so they have an understanding of what it is that they're there to accomplish in treatment, regardless of how or why they got there.

Jenny B., Area Treatment Facilities Chair: Scott came to me and asked me about this and I say always put in a motion for anything you feel strongly about. I believe that...and Reilly will help me if I'm wrong...any material that we want to submit for a pamphlet would go to [the General Service] Conference, and so that would be where your work would be. I think more information is always good. The only thing you said that I had a little trouble with is that we don't tell them how they do treatment, that's not up to Alcoholics Anonymous. We tell them how they stay sober after they go to treatment. That's all I have to say about that.

Scott F.: I would never presume to tell the treatment center how to do their business.

Rod, DCM District 3: The thing I was worried about is this a proposal to submit a motion to GSO? **Scott F.**: I think she just said that this is motion to be presented to GSO for their consideration, because this would serve all of Alcoholics Anonymous, wherever a treatment center existed.

Joel S., DCM District 19: I have a friendly amendment for the motion maker, that we amend the motion to reflect what's been said at the mic. We amend the motion to say we move that Area 58 submits a proposal to the General Service Conference to create such a pamphlet.

Scott F.: I'd be more than willing to do that

Denise, GSR District 5: What bothers me is the wording, "To offer suggestions and distinct directions toward how to maximize success in treatment"? Or is this success in AA after treatment, by knowing what AA has to offer. Because I don't think we can offer success in treatment.

Scott F.: Our intent here is to provide the kind of information to those in treatment, to help them understand what and why they're there, to help them maximize their success while they're in treatment, to give them a better understanding of what it's all about. And then it also would lead into what happens afterward as well. So it sounds to me that maybe this needs to be rewritten with a lot of understanding and a lot of information beyond what we put here.

Denise: May I speak again? I think we have nothing to say what happens in treatment. We do have something to say what happens and how people can conduct themselves coming from treatment into AA. But a pamphlet from AA telling people how to succeed in treatment, isn't that affiliation?

Ron W.: I ask that you speak once at the mic, in turn please.

Scott F: I am more than willing to withdraw the motion and rewrite it for presentation later.

Motion is WITHDRAWN

Terri O., GSR District 15: Would you just give us direction on what happens to a withdrawn motion? We don't take it back, we don't talk about it? Would you clarify?

Ron W.: Yes, we don't need to talk about it or take it back to our groups. The motion maker will rewrite the motion and probably present it at the February assembly. Don't talk to your groups about it, they don't need to know anything about it because it will be a completely different motion.

New Business Completed

During additional reports, a point of order was made:

[Unidentified person]: I have been given a point of order by a past-Delegate. On the 2017 [Treasurer's] report, Corrections is in a negative balance. Do we need a motion to move money?

Ron W.: The final report of the Treasurer will reflect a zero balance. He hasn't given his final report yet. Thanks for that information. Was that from Gus? [laughter]

Report on National Corrections Conference

Report given by Roberto F., Area Corrections Chair. [This report can be found just beneath the Corrections Committee report in the Full Reports section.]

Final Treasurer's Report – John A.

We came into the assembly with: \$39,107.71
We wrote checks totaling: \$10,388.96
Leaving the Assembly with cash in bank: \$28,718.75

I was just asked by the Chairperson, Ron, to touch on the Corrections negative balance. Randy mentioned there was an entry error in Finance. There's also an entry error on the corrections line that allowed the Corrections to go over budget. Unlike what happened with the Area Chair, the Corrections, they still have money in the bank at the end of the year. When they close their books, the money that they return, there's actually going to be a budget surplus in Corrections. When you get the Fiscal Year End statement, it's not going to show a negative balance. There are two other negatives in the [Treasurer's report] you might ask questions about. Two of them are self-explanatory. One is for advances to assemblies. We don't budget that, it's money that we pay out and is returned so it shows up as a negative in the budget balance. The other is in the miscellaneous line, and that's something we don't budget for, those are expense that just come up throughout the year. We did have that one-time expense of new equipment for the translation committee. The third is also in the Administrative section and it's our website. I don't have the financial statement, but you can see it's in the negative by 80-some dollars. What happened there is, over the summer there was some discussion, our website was falling victim to some attacks and there was discussion that we should up the security on the website to keep the website up and going and so it doesn't get taken over by other another country or something. The web guys went ahead and took that action and GoDaddy debited that \$80 straight off our account. That's the status of overbudgets. If you have any further questions, don't hesitate to call me or email or track me down personally. Is there anything else? Once again I'd like to thank you for letting me be of service.

DELEGATE REPORT AREA ASSEMBLY November 19, 2017

Hi everyone, my name is Reilly and I'm an alcoholic. My home group is Wildlife, in District 13. My sobriety date is August 7, 1966. This is my last report as your current Panel 66 Delegate.

Since last Assembly, I've been finishing up Delegate Reports to Districts, finalizing lots of reports to and from the General Service Office, and getting ready to transfer everything I know to Vera.

I can't tell you how wonderful it has been to serve you the last two years. DCMs all over Area 58 are active, knowledgeable, and dedicated to serving their Districts and this Area. It's been a delight to work with all of you. Meeting GSRs all over the state has been great! I've learned so much about groups at the local level. Oregon Area stands out in all ways for its leadership and participation.

How many new GSRs are here?

New DCMs?

Welcome! These Area Officers and Service Committees are here to serve your groups. Ask questions, listen to reports, take the pulse of your own group. Find out all you can about Alcoholics Anonymous. With accurate information and a deep sense of Unity, your group will be better able to help newcomers find sobriety.

There is a lot going on in other places, too. The General Service Office and Trustee Committees are busy working on the tasks we left for them from the 67th General Service Conference. Here are some highlights from the recent General Service Board meeting:

- Public Information committees can now link local broadcasters to a page where all current video PSAs can be downloaded in HD Broadcast quality.
- The first Google for Non Profit You Tube account launches in January.
- A questionnaire is being circulated on AA's website for shared experience on the expressed need for a pamphlet for AA members who are Deaf.
- Sharing is also requested from local committees who are working to carry the message to veterans and members of the Armed Forces.
- Grapevine circulation is ahead of budget so far this year, but slightly down from last year.
- The newest Grapevine publication, Voices of Women in AA, has sold 10 times what we thought it would. There is clearly a need for this message.
- The communications audit that is part of the Strategic Plan has been started, with emphasis on efforts of Cooperation with the Professional Community.
- We asked for a book of Bill W's Conference talks. A draft of that book is underway.
- Remember the Translation Agenda Item from year before last? The one that would cost \$350,00 a
 year? The 67th Conference instructed GSO to get translation in Spanish and French done for 2018
 Pre-Conference, using whatever methods are available. They have worked hard to develop a new
 plan, using both professionals and volunteers. The cost might be around \$100,000. That's quite a
 savings!

- A new group has formed in Tashkent, Uzbekistan. This is the first AA contact we have had from this
 country in three years, and the first group. GSO sent a package of literature to assist in carrying the
 message.
- The Board has accepted an invitation to participate in Al-Anon's 6th International Convention in Baltimore Maryland, July 5-7, 2018.

On the Financial front, AAWS net profit at the first 9 months of 2017 was higher than anticipated, due in part to strong literature sales and increased 7th Tradition contributions. Grapevine is also doing well so far this year, with interest income on deposits, and management continuing to keep costs below budget. La Vina's shortfall for the first 6 months is less than expected. Remember that the Conference has asked to keep La Vina as a supported service, so we don't expect the revenue to be self-supporting at this time.

The Reserve Fund balance represents almost 10 months of operating expenses, which is in the range we like to keep it at.

We have some figures on the \$7.27 on 7/27 challenge for 2017. The General Service Board sends gratitude to the Pacific Region, particularly Oregon Area, for this grass roots effort that has now spread throughout the entire service structure. Last year they were caught completely by surprise, and could only attribute about \$4000, but we know that Oregon Area contributed almost \$12,000 by ourselves. This year so far GSO has identified 1,857 contributions in this effort, totaling Drum roll, please \$76,829. Financial analyst Michael told Joel, our Trustee, that the people who process contributions were on the lookout for notes that made reference to \$7.27. Can you believe everyone followed the directions? I can't wait to find out what date we're going to rally around in 2018.

When groups and members like what the Board and GSO are doing, they contribute more, and they withhold contributions to indicate discontent with policies. This is Concept 7 in action, by groups using power of the purse for effective control. The fact that the 7.27 challenge was so successful, and the news that AAWS, Grapevine, and La Vina are all doing better, shows that AA Groups are voting positively with the power of their purses. Groups also use this tool as a negative force to display dissatisfaction, and occasionally we hear a group cry "AA can't use our money for that! We're just not going to give them any more." It is absolutely their right to express disapproval in this manner.

But there is a myth that AA group money pays for everything in AA, while it, in fact, barely cover Group Services. For instance, legal fees or any other Support Services are never paid out of group or individual contributions, only from the Reserve Fund. Revenues from 7th Tradition and Publishing pay the cost of services provided to the Fellowship and publishing first. Then we determine all the future cash flows that will be needed in the following year for group services and publishing and those funds are allocated first.

Any excess is transferred to the Reserve Fund, and that is composed, at this point, primarily of literature profits and investment income. If Group Services and Publishing ever both fall short of being covered, cash would have to be transferred back from the Reserve Fund to make sure that groups and literature services are always maintained.

Keep in mind that, prior to reaching the point of transferring to the Reserve Fund, almost all Contributions have been used for Group Services, therefore very little of the Reserve Fund is ever composed of group or individual contributions. When groups vote with the "power of the purse" - as is their right and responsibility to do! - the result is that contributions may fall short of what it takes to support Group Services. Contributions rarely ever reach the pool of funds that are used for Support Services.

I know that money flow is hard to follow, but I think it's a responsibility that Trusted Servants need to be familiar with, and be accountable to those they serve in every area.

Now – what's coming up for the 68th General Service Conference? Here are a few things that will be forwarded to the Conference:

- There will be a proposal for a new pamphlet for long term incarcerated inmates.
- The Subcommittee on Safety Language in Literature will present its report.
- There is a request for a pamphlet on AA's Three Legacies, to include members sharing about Recovery, Unity, and Service.
- Also on deck are more requests for a new and different pamphlet for atheists and agnostics in AA, as
 well as a request to publish the "The God Word". That is a pamphlet currently published by the
 United Kingdom. In addition, AA in the UK has asked if we could help, as many orders they have
 received come from North American groups and members who have heard about this piece.
- A discussion on intellectual property and fiduciary responsibility, including protections for AA copyrights and registered marks. Look for lively discussions at Pre-Conference workshops!
- The next Conference will also discuss motions from Areas regarding reorganization of the AAWS
 Board and the General Service Board, as well as a motion to censure the General Service Board.
 These are in response to the Board's recent decision to authorize legal action regarding the printer's
 manuscript of the Big Book.

There will be a lot of opportunity for love and tolerance in action at our Pre-Conference Workshop in February!

And lastly, I want to share that we recently lost a long-time member of the Port Dover, Ontario, AA Group. Harry G was 98 years old and had 71 years of sobriety. That's a lot of "One Days at a Time!" He founded Port Dover's group in 1949 and continued to be active. Harry shared his belief that "AA heals itself, if you let it".

As we continue to bid farewell to members who are linked with AA's past, it becomes more and more important that we preserve our history. We, the Trusted Servants of our Groups, Districts, and Areas, respect and teach the lessons learned from AA's past. We are the guardians of the Steps, Traditions, and the Concepts, without which we cannot survive for long. We know that change comes slowly, deliberately, and with the caution born of surviving a deadly disease. We gladly accept the experience of the past and take responsibility for the future, so that AA doors are open when children born today come looking for sobriety tomorrow.

It is with deep gratitude that I end my last report as your delegate, by recognizing that every person in this room today is part of AA's past, for a little bit or a long time. Each of us has had a share in AA's history. From today forward we are the future of Alcoholics Anonymous. Let every one of us each be accountable for everything we do here.

Thank you for allowing me to serve.

Q4 Treasurers Report November 19, 2017

Good morning Oregon Area,

My name is John, and I am an alcoholic. My sobriety date is July 13, 2000 and my home group is the Keys to the Kingdom Group Roseburg District 13. I am humbled to be serving as your alcoholic treasurer.

So, are you ready to talk about the money? More specifically your money. On your tables you will find the Q4 2017 Oregon Area Financial Statement. I will give you a moment to locate the financial statement as we are about to go over it.

As the dates show, the 4th Quarter began on September 15 – the Friday of our last Assembly and ran through November 16th the day before the start of this Assembly.

Let's start at the upper right side in the box labeled cash in bank. Here you will see that we started the 4th quarter with \$38,453.14. The first section there on the left is our income and we will be looking at Q4 which is printed in bold. The bottom line in that section shows our income totaled \$15,615.79 – which Lisa went over in detail in her report.

So let's move on to the expenditures; again we will be looking at the Q4 column in bold print.

The first section of our expenses shows money paid out to Officers and Service Committees for the work they do for the Area in-between assemblies. I know that any of our service committees would love to tell you all about the work they do if you ask them.

Next please drop down to the travel section. You will notice that we spent \$4,320.00 out of the area committees to assemblies line. The \$4,32.00 represents the \$160.00 travel stipends given to the area committee members to attend the last assembly. As you can see we also wrote \$70.00 in checks to DCM's for travel to assemblies; while it is the responsibility of each district to fund their DCM, this budget line item is intended to help those districts that cannot fully fund their DCM.

Finally, we will look at our administrative expenses. This section outlines money we paid out to such things as rent for the archives, our PO Box and insurance.

Now if you look at the bottom of this column you will see that these expenses for the 4th Quarter of 2017 totaled \$14,961.22, also shown in the right hand margin. Our overall expenses were down by 3% compared to the same quarter in 2016. So, this brings our Ending Balance coming into this Assembly to \$39,107.71 which is shown in the last box on the right hand margin.

The very last section is the Outstanding Assembly Advances, totaling \$3000.00. These advances are given to Host Committees as seed money, and are returned to the area at the conclusion of their assembly.

We've participated in District's 27 workshop in Milwaukee. Thanks Todd. We held our 2nd Annual Corrections conference in October. Although not as well attended as our first, the content put forth by the DOC participants was insightful and provided an opportunity for the fellowship to get a view of how the volunteer vetting process works. Nicole Brown , the head of volunteer programs for DOC shared some of the ever changing processes involved in getting an AA member badged. Lunch was fabulous (and spicy), It was provided by our linguistic districts who always do such a fabulous job. Muchas gracias como siempre.

17 prereleases have been received since the last co-chair report. Most were assigned volunteers and some were assigned volunteers that did not connect and other was not received in time. I just got back from the 1st National Corrections Conference and I must say it was an experience I will not soon forget. I will share that the participation of over 350 volunteers from 34 states, 4 Canadian provinces, and Puerto Rico brought to bear the collective wisdom of ordinary people doing extraordinary work. Volunteers from institutions like San Quentin, Folsom, Ryker's, and Huntsville shared their experiences, frustrations, and hopes. To hear from former inmates, some who were consigned to life terms and hear how their ability to practice our program, first behind the walls and more importantly back out in their communities after release showed me the importance of the AA process.

Here are the results of the 3rd Annual Corrections Book Drive:

There was a total of 280 BBs, 80 12x12s, and 30 mixed Spanish literature. Thank you Area 58 for your contributions.

The Overall winner was District 21, with a total of 145 books. They will get Pizza and Ice cream. District 31 with over 40 new BBs. They'll be receiving ice cream, as will District 6, also with 40 new BBs. A special shout out to the Make my Day morning meeting in District 5 who after the bell came in with a total of 3 cases of new soft cover BBs. You guys are awesome. National Corrections Conference Report

Hello Oregon Area. My name is Roberto F. and I'm an alcoholic. I have the privilege of serving you as your Oregon Area Corrections Chair. I want to take a few minutes to share with you about AA's 1st National Corrections Conference, which took place in St Louis, Missouri this past weekend. First let me give you some numbers associated with the event. There was a total of 387 registered attendees. 34 states were represented, 4 Canadian provinces, and Puerto Rico. All of these numbers exceeded the hosting committee's wildest expectations.

The weekend was full of informative presentations, including participation from GSO, correctional staff, drug court judges, long time volunteers, and former inmates.

Represented were members participating in AA service in level 5 institutions like Folsom, Huntsville, San Quentin, all the way to work release transitioning institutions in Georgia and everything in between. We got to hear from two men who, thanks to the 12th step work of volunteers and the miraculous change from being in the program, had their life sentences rescinded and are now free and productive members of society.

The numbers for substance abuse in Oregon are similar to national. Close to 80% of the correctional population have substance issues. Texas, because of their progressive approach to correctional work and close work with parole and probation departments claim a 21% recidivism rate. The national average seems to be at around 50%.

The information provided by this conference was massive. To hear how other Areas have surmounted common correctional service obstacles was encouraging. To learn from others' trials and errors is invaluable.

The foundation of years of corrections work laid down by Tom I. reverberated throughout the weekend. Words like "communication", "cooperation", and "consistency "were used again and again in dealing with the incarcerated, administration, and our fellowship. The thought that these men and women behind the walls should be treated as human beings, not rehabilitation projects, gave me a moment of pause to consider my own approach.

We were presented with technology driven ideas such as the use of Jpay in the Georgia prison system. Inmates are allowed the use of iPads, which hold such things as family pictures, music, and legal documentation. Also, their recovery literature such as Big book, 12×12, and daily reflections, which are downloaded and stored on the devices. They are library free in a few institutions.

Northern California H & I presented to the conference a well-researched plan which would allow for video meetings and possible one-on-one step work to be done via Intranet. This would allow inmates in institutions that are in hard to access locations the opportunity to consistently have meetings. Saving drive time, travel expenses, and opening the door for more volunteer participation that otherwise would be leery of the institutional setting. Their hope is that a pilot program can be instituted in a state or region that already has the pieces in place.

Grapevine

Hello Oregon Area, my name is Gus, I'm an alcoholic. I'm currently serving you as your Grapevine representative. I'm going to try to do something...this started last night. Last night I hung out with a fellow lunatic named Chase B. and he suggested that we eat our leftover barbeque brisket, baked beans. and cole slaw at 10:30 last night. I knew that was a mistake but Chase can be fairly persuasive with a knife and fork in his hands. What happened next is that I fell asleep for a couple of hours and then the rest of the night tossed and turned. It was not a pretty picture. And in the tossing and turning I kind of made a decision about what I was going to do today. I have a prepared report, which I'm not going to use. And you're going to have a real report in the minutes. But my very first report to you, standing up here, was at a lectern like this, I was an Alternate DCM, my DCM didn't show up and I wasn't given a copy of the report. Eric K. was Alternate Chairperson, and he called the roll, and he said District 6, and I got up and said who I was and that I was the Alternate, we didn't have a report. And crafty devil that he is, he said "Oh Gus, why don't you just come up here and tell us what's going on in District 6". I didn't know enough to say I'm not really prepared to do that. I just walked up there. I thought that was an instruction that I needed to follow. I had been, and still sometimes am, intimidated to go to the mic and talk about a motion during the business meeting. But what happened to me that first day up here, was that I was totally at ease talking to you like this. There was something different about that. It really is quite an intimate experience, it's almost like we're having a conversation one-on-one over coffee somewhere. It's just a wonderful thing. And so I came in to this idea of talking to you unprepared and I figured that it would be equal dignities if I went out that way as well. So that's what I'm going to attempt to do. Jim has been kind enough to give me extra time and I'm not really going to pay attention to the buzzer or any of that stuff. What are you gonna do? I'm done. In 20 minutes I'm banished to the back of the room. What are you gonna do?

Let me just cover a couple of little things about details that happened for Grapevine so it really sounds like a Grapevine report. I had a couple of writing workshops scheduled for the last quarter, I thought I was going to go out with a flurry of activity, my grand plan that I would be able to come up here and tell you that I worked 'till the last minute, all that stuff blew up. In my mild disappointment, I'm saving oh my God what am I going to do. Then I realized that if a workshop was supposed to happen it would have happened. So maybe these workshops weren't supposed to happen and maybe God's plan for me was different. The other things I could tell you about Grapevine is that we have a new book, Voices of Women in AA, it's a compilation of 61 stories previously published in the Grapevine. It's available for \$11.50 and it's got some great stuff about women pioneers in AA. There's a new Spanish book that's been published called Un Día a la Vez, which is One Day at a Time. It is a compilation of stories that were published in La Viña from 2007 to 2015. The Grapevine subscription app has been improved and upgraded. It's now available on all platforms, but the actual platform itself in all its forms has been improved and you will like it, so check it out. And the last thing I can talk about is the four seasons of service contest, which wraps up at the end of the calendar year. You can find the details of that in your Grapevine magazine on page seven. The Pacific Region is currently in second place, we have 13 submissions, we're only one behind the lead, so I expect you to go out there and generate some stuff to push that number up. I'd like to go out a winner if it's possible. That doesn't really happen all that often, so you could put a smile on an old man's face by doing the right thing. Reilly then could take all the credit for it because then she'll report on it, which is really good, it's a perfect thing, right?

As you may have gathered, this is my last report. I really struggled with this. There was an idea rolling around in my head that if I didn't write my last report then you would owe me one and I really wouldn't be done. That's clearly alcoholic thinking, right? So I struggled through and wrote this report which I'm not using now. What can I say about my time here. I have had a wonderful time talking to you from up here, and being of service to you. Every time I've talked about this with friends on the weekend I've gotten emotional and there's a good chance I'll have a breakdown up here which you can all make note of because it doesn't happen all that frequently. Along the way I've made a lot of friends, I've learned a lot of things, I've learned a lot about AA and a lot about Oregon Area and a tremendous amount about myself. The truth is I have received far more than I gave you and I've been blessed by the opportunities

that you've given me. I've been up here talking to you in one form or another for like 17 or 18 years it seems like. And I've had a great deal of fun doing that, and I hope you've had a great deal of fun with that as well. The things that are noteworthy for me is the progress I learned about different things. I never started out to want to be a leader in AA. I loved the Area so I didn't want to be without a job when I got finished with my tour as DCM and you wound up electing me to a position. I didn't realize what the honor of that meant about being elected as an Area Officer until I was elected Area Chairperson and someone pointed out to me that I was one of only 93 people in all of North America to have that honor. I learned about the honor and privilege that was into my service career. I didn't learn about AA leadership really, and what that really meant, until my second year as a Delegate when at PRAASA the second year Delegates were asked to talk about leadership in AA. I researched it made a presentation on it and I realized that I, through the years, with your help, had actually become a leader in AA, even that's not what I started out to want to do. It just happened. The leadership is all about being a servant, it's not about actually leading, it's kind of leading from behind. I learned as a Delegate how to in fact allow you to direct me, to put aside my will in favor of your will, as I've done in my recovery with God's will. It was a miracle, it was a great great thing. I'm about to move to that back table. There are lunatics back there. Be very careful when you approach that table. But the table is filled with my peers, and mentors, and really good buds. I'm gonna have a great time back there with them. They have a great time even without me but it'll even be better when I'm there. I'm a party quy. I want to tell you that what goes on there is a lot of inventory, none of which is theirs. You are being judged all the time. Now we never tell you what those judgements are, unless you ask, so be very careful about what you ask. Thank you for the great honor and privilege of having served you. My heart is full of joy and gratitude for all that you have given me. I've bene blessed by these experiences. I hope that many of you get a chance to do this stuff, to continue to work for Alcoholics Anonymous in Oregon Area and experience the great joy that it brings. This has been the ride of a lifetime and I've loved every minute of it, thanks.

[Secretary's Note: Gus gave the above Grapevine report extemporaneously and it contains about as much information on the Grapevine as the amount of vermouth in the martinis I used to drink. Gus's preprepared report below contains a bit more Grapevine-related material.]

Hello Oregon Area! My name is Gus P and I am an alcoholic. I am currently serving you as your alcoholic Area Grapevine Committee Chairperson. My sobriety date is 12/1/93 and my Home Group is the Downtown AM Group in Eugene, where sobriety begins at 7 AM Monday through Saturday each week. Please join us whenever you are in Eugene.

This is the unabridged version of my long-form Grapevine Report which will appear in the Area Minutes. This expanded report is offered because the 3-minute timed Assembly Business Meeting Report does not permit complete coverage of Grapevine topics.

It's been about two months since we last got together in McMinnville in District 22 to elect our new Area officers. At the September Assembly, I scheduled two Grapevine Writing Workshops, hoping to finish my Grapevine tour of duty with a flourish of activity. However, unanticipated events resulted in both workshops being cancelled. I was disappointed! My grand plan fell apart before my eyes; and I found solace in the belief that if those workshops were supposed to happen, they would have! Thy will, not mine, be done!

Two weekends after our September Assembly found me at the Sky Camp Men's Retreat near Dexter, Oregon, where I had a wonderful time hanging out with some special AA buddies. This year, I was the retreat organizer, aka the "retreat grunt", charged with the responsibility of trying to keep the Sky Camp Men's Retreat alive after several years of low attendance and increased expenses. We pulled together, cut costs, and upped our attendance by 50%. We even have some money left over to help build a

prudent reserve again. I was overwhelmed by the generosity of my fellow retreaters; and felt grateful just to have been there with them. It was a spectacular retreat!

Also during this quarter, I was the speaker at a local speaker meeting, attended the "Take Your Sponsor to Dinner" Fundraiser hosted by the February 2018 Area Assembly Host Committee, and had dinner with Dean B, the Panel 64 Delegate from Area 08 San Diego-Imperial, who was in town on business.

During this past quarter, the Tuesday Night Men's Workshop continued reading and discussing the book "AA Comes of Age". The 15 participants are taking on this new assignment because one senior member said he wanted to finally finish reading this book before he passes on, and he thought he'd only do that if we did it as a group. That made perfect sense to the rest of us and thus we are almost halfway through the book.

The AA Grapevine announced that December 1st is the deadline for submitting your photographs for consideration for inclusion in the next Grapevine wall calendar.

The Grapevine Subscription App can be ordered online for \$23.88 for a 12-month subscription; and is available on multiple platforms. You can access the magazine on your tablet or smartphone monthly. You can download your issue for offline viewing, archive past issues, get a sample audio story or selected video and email your favorite articles to friends.

The AA Grapevine has announced that it recently published a new book entitled "Voices of Women in AA", which is available online for \$11.50. The book is a collection of 61 stories by or about women who contributed to AA early in its history, followed by stories by some of the program's earliest female members. The stories demonstrate the various ways women alcoholics — often with great courage — find sobriety in AA and embrace the program to live rich and rewarding lives.

Grapevine has also published a new Spanish book entitled "Un dia a la vez" ("One Day at a Time"), which is available online for \$10.50. The book is a collection of selected stories published in La Viña between 2007 and 2015.

The AA Grapevine "4 Seasons of Service" Challenge is continuing and runs until the end of 2017. The Challenge asks us to write and share our or our Groups' experiences on various topics in up to 300 words and include an anonymity-protected photo, if you'd like. Your story may be selected to be published in a special service issue in the Grapevine in 2018. So far in the Challenge, the Pacific Region is second overall with 13 submissions. For details about the Challenge see page 7 of the current Grapevine magazine or go to the Grapevine website at www.aagrapevine.org.

The Grapevine published two issues since our last Assembly. The October issue's theme was about "AA in the Military"; and the November issue theme was "Women's Voices".

The October 2017 issue included a story on Step 10 written by an Oregonian named Susan from Ashland, Oregon. The story entitled "Jumping to Conclusions" was a fun article about the writer's experience with the wild kids next door. The article reminded me of my own difficulties in earlier sobriety with reacting first without a moment of pause or without the benefit of some reflection. The author, like myself, ultimately resolved the situation and her unsettled feelings about how she initially handled the situation by working the 10th step. It seems that her sponsor gave her the same advice that my sponsor gave me – "You have to change! That's what this whole thing is about".

The November 2017 issue of the Grapevine also had a submission in the form of a Dear Grapevine Letter from an Oregonian named Agnes from Sisters, Oregon. In the AA News Section of this issue there was a wonderful one-page article about how to make contributions to GSO online, using the recurring contributions feature. This short article is definitely worth reading. I also enjoyed the article on

Tradition 11 entitled "To Break or Not to Break", in which the author addressed several of his personal questions concerning anonymity. This is another article worth reading.

I have been a Grapevine reader from my early sobriety and still love reading our little magazine. Each issue is filled with wonderful stories and letters from AA members, and I always find something to help keep me informed and enhance my capacity for compassion and spiritual growth.

Now comes the part of my report that I have struggled with in organizing my thoughts and in preparing a written report.

It's rotation time again here in the Oregon Area, and once again I find myself leaving a service position which I finally feel comfortable in, but this year I will not be moving on into another service position within our Area.

This is my last report to you as your Grapevine Chair. The last two years seem to have just gone by in the blink of an eye. And while the time seems so short, I have a full array of happy memories of my time in service these last two years. You have treated me with kindness, respect and love everywhere I went. You have blessed me with a full and grateful heart.

I first came to an Oregon Area Assembly in 1997 as a replacement GSR, with the idea that this would be simply be a drive-by for me. That drive-by quickly turned into a one-of-a-kind love affair. But now it's time to rotate out, not rotate on. As I move to the back of the room to sit at the Past Delegates' Table, I realize how very much I will miss having the opportunity to talk to you from up here like this in the future. I have had a great time engaging with you from up here. And I hope you enjoyed it, as well.

I now join my pals at the back table. These folks have been my 'of counsel' support group, my mentors, my peers and my service sponsors. I believe that I will have the time of my life hanging out with the Past Ds, certain that we will taking a lot of inventory at the back table, none of which will be our own. :>) I hope that my BFF Chase and I will get to do some "Dog and Pony Show" work in the future, continuing our journey together, enjoying many more adventures.

Thank you for all you have given me. I am so glad that I fell in love with the Oregon Area and all of you. I have been blessed by the experience! Thank you for being patient with me and for the opportunity to serve the Oregon Area.




