FEES & PAYMENT

Registration fee is \$35 per child. Once registration is confirmed, registration fee is non-refundable/non-transferable under any circumstances.

For new students, textbook fees of \$20 will be collected in the first week of semester. Every student will get a set of 3 Chinese textbook & workbooks published by Jinan University of China and 1 Math workbook.

For students who attend arts classes on Wednesdays and Fridays, arts supply fee is \$25 per student each semester.

Tuition includes pick-up fees. Payments will be due on the first day of class each month. Please make checks payable to **RedApple Learning Campus** or **RALC**.

For families with two or more children enrolled (full-time only), the first child will pay the regular rate of tuition and siblings will receive a 10% discount.

There is no refund for missed classes due to students' absence (unless class cancellation is announced).
Late pick up fee will be charged after 6:10pm (\$1 for 1 minute late).
