JUST THE FACTS

The Mental Health Recovery Board (MHRB) serving Warren and Clinton Counties unanimously placed a renewal of the existing 1 mill levy on the November 2, 2021 ballot. The levy raises \$6.5 million annually, which won't raise taxes. Mental health and addiction treatment services are an important community safety-net for the residents of Warren and Clinton Counties. This levy is necessary to continue helping children and families in crisis.

Renew THE MENTAL HEALTH LEVY

It Won't Raise Taxes.

1. 1,500+ residents received services across our network. This renewal keeps those services available for families.

2. 1/3 of the clients served in our treatment network are children.



3. Renewal of the levy **maintains mental health services for children and families** who cannot afford to pay for them, have nowhere else to turn, and could go untreated.

4. Levy funds continue suicide prevention programs, including for youth and elderly.

5. 51% Percentage of support that the local levy provides of the annual operating budget that makes services possible.

6. **Renewing this levy preserves treatment and housing** for those with severe mental illness.

7. Without this levy, the agencies funded by the MHRB would struggle to provide existing treatment, housing and care programs.

8. The Mental Health Recovery Board is **fiscally responsible and accountable**. The voter approved levy is renewed every 5 years.

9. State funding has continued to lag and is chronically insufficient.



10. \$2*/month Continues to help families in crisis with an important community safety-net. *For each \$100,000 of property valuation.
