NEW BUSINESS

The swearing in ceremony for elected official Michelle Meyers took place with Mayor Penrod swearing in Michelle Meyers as Vienna's Treasurer.

ELECTED/APPOINTED OFFICIALS

Mayor Penrod noted that Stephani Borders had volunteered to take new pictures of the Council to update the City of Vienna web page possibly, prior to the next meeting.

Mayor Penrod also updated the Council on the property located behind Rusty's. and 118 N. 4th St. property, the Engineer is reviewing the stop signs on 6th St., Flow test for the new Johnson County Court complex and road closure during construction. That Southern 5 had noted there could possibly be grant money for sidewalks, body cameras and vests for P.D., along with possible options for the water system upgrades.

Supt. Racey informed Council of a large outstanding bill for water usage. Council suggested that the City Attorney send a letter.

Alderman Owen advised Council that the Dedication Ceremony for the new Phil Morris Amphitheater is coming together with food and drinks, and music asking everyone to attend. The event will take place on June 5th, 2021, starting at 12:00 P.M. at the Amphitheater in the Vienna City Park.

Alderman Owen discussed the property located at 1800 St. Rt. 146 East and the City camping tax.

Alderwoman Hill discussed the possibility of hiring someone to clean the City Park a couple of hours a week. Discussion centered around this issue.

It was decided that the Park Committee would check on updating the City of Vienna pricing and times for pavilion and amphitheater rental and Ordinance.

Fire Chief Brent Williams advised Council he would forward information on the American rescue plan concerning funding spending restrictions.

As there was no further business to discuss, Alderman Owen made a motion to adjourn the meeting. Alderman Racey seconded the motion. Motion Carried.
