These attorneys will consider a person's financial situation when they assess legal fees for a particular service case. This list is updated in on a quarterly basis.

This list will be distributed to the various First Judicial District Courts, (Jefferson and Gilpin Counties), and to a variety of other venues that assist the citizens of the First Judicial District Jefferson County. This list is intended to help parties in conflict, who do not qualify for legal aid, but who still are in need of financial assistance in obtaining legal services.

**Please be aware that these attorneys are not required to accept any case that comes to them by way of this list – only that they have made their services available at a discounted fee, should they choose to accept a case after speaking with a party.**
