

LAKE SHADOWS POOL RULES AND INFORMATION

Revised July 2017

Welcome to the Lake Shadows Pool! We want all of our families to have an enjoyable experience at our community pool. This document will answer some of your questions as well outline the pool rules. Please discuss these rules with your children so that we can have a safe and fun swimming season.

The Lake Shadows Pool is meant to be used by all property owners who are current on their HOA dues. By purchasing pool tags or guest passes, you are helping to pay for the expense, maintenance and upkeep of the pool. It's very expensive to operate the pool, so every little bit helps...we thank you for your support.

A pool tag may be purchased for the immediate family of the homeowner for \$30 each. This will include homeowner, spouse and children who live at the residence. A grandparent can also purchase up to four tags for grandchildren. Families who rent homes in Lake Shadows can purchase tags for their family with proof of residence as long as the owner of their property is current on their dues. Your tags may be purchased at the pool during open hours. NO CHECKS /cash only.

You may also purchase a guest pass for your family or friends that are visiting you for the day and would like to spend time at the pool. The property owner must always be present with their guests. Guest fees must be paid in cash only. All guests not monitoring children will be required to pay \$5.00 per day entrance fee.

The pool will open Memorial Day weekend and closed on Tuesday May 29 for maintenance, The following week the regular schedule will resume opening Tuesday through Sunday. The normal pool hours are Tuesday-Saturday 1-7pm and Sunday 1-6pm. The pool will be closed on Mondays for maintenance with one exception. If July 4th falls on a Monday, the pool will be open Monday, July 4, 1-7pm and closed Tuesday for Maintenance.

The pool may be rented for \$50.00 per hour; this includes 1 Lifeguard/Monitor. If you have more than 25 swimmers, you will need 2 Lifeguards/Monitors which will cost an additional \$10 per hour. The pool can only be rented during non-operating daylight hours on operating days..

The Lifeguards/Monitors have complete authority at the pool. If you do not want to follow his/her directions, then you must leave the pool area. If you wish to discuss the matter further with the pool Manager you may do so at another time, but at that moment, the Lifeguard/Monitor has the authority. Any person posing a severe danger to themselves or others will be asked to leave the pool area immediately. For not following the rules, the Lifeguard/Monitor is authorized to put the person in "time out", sitting at a distance from the pool for 15 minutes. The second offense that day will result in the person being expelled from the pool for the day. In order to re-enter the pool, the person or parent of the person under 18 will need to have a conference with the pool manager to try to resolve the issue. If a person has been expelled from the pool for a severe infraction of the rules he will need to address the LS Board at the next regularly scheduled meeting before having access to the pool again.

Children must be 12 years old or older by June 1st to swim without an adult's supervision. In order to supervise a child under 12, the person must be 18 years old or older by June 1st. All toddlers must be potty trained or wear a "little swimmer". The same water and filter system is used for both the wading and large pool, so this is an important health issue.
