Old Business:

Meadow Lots:

Mike Falla surveyed the lots and came up with 4 other options for division.

Mike Deyling was also here and recommend that each property have their own tank and share a leech field. Joan will provide more information by next month's meeting.

Snug Harbor:

Marian estimated that Snug Harbor's cost of insurance was \$1,500 but it may be closer to \$1,600. She will confirm with the insurance company.

The water heater is still having issues and Dom has recommended buying an on-demand water heater.

MOTION: Marian will purchase a water heater at the best possible price for Snug Harbor. Passed.

The request for bids still needs to be done for the trim repair.

Store:

Lisa asked about the insulation under the building that was apart of the estimate for recent work done. Marian will ask Lucas about it.

Kathie asked if the propane tanks could be moved back against the building or in a better location

MICA Building:

A new contract for a waste water operator has been signed. Water Quality in Wisscasset estimated \$1,800 a year.

The septic tank needs to be pumped. Marian will ask around to see if anyone else needs a septic pumped so we can share the truck.

There is no easement filed for the overboard septic. Marian will look into it.

Stew is no longer interested in painting the MICA building since it has lead paint. Marian will get an estimate from Greg Knight who plans to come out in the fall.

Mott will fix and reinstall the screen doors at the post office.

The Looks:

The septic will be pumped on June 13th. Lucas offered to help. The truck is being shared with Jim Balano and will also pump Snug Harbor.

Jacobson:

Mike Falla surveyed the path and the easement will be filed once all parties approve.

Fundraising:

The lobster bake is June 10th. We will be selling T-shirts for \$20.

Amy Williams Beers will bring out her donation for this year's painting raffle next week.

There was much discussion on how many items we will have at the auction in August.

Trustee Handbook:
