Use the above graphic picture or link to figure your new property taxes if Prop 13 is overturned.

- Compare what you pay now to the amount you will owe using the Howard Jarvis calculator website. This is the Yearly amount you will pay on a residence in California, IF we return to the formula that was used to figure property taxes before 1978...the year Prop 13 was passed.
- Before Prop 13, property tax was based on the assessed market value of your home. Taxes were 2.67% of this amount each year.
- After Prop 13 passed, taxes were figured on a base of 1% of the purchase price of the home and yearly increases in the base were limited to 2%, regardless of any changes in the market value.

Prop 13 has protected homeowners from losing their homes for over 40 years, but that is about to change if the legislature gets its way. They have placed a measure on the 2020 ballot that will cut off all California businesses from Prop 13 protections.

- Businesses will no longer have the protections of Prop 13 and will immediately be charged taxes on the market value of their property instead of the purchase price.
- ALL businesses will face these tax increases: retail stores, shopping malls, car dealerships, movie theaters, gas stations, factories, restaurants, hotels, car washes, liquor stores, grocery stores... small businesses in strip malls ...Any place you shop will be hit with higher taxes.
- Consumers will cover these taxes or businesses will be forced to relocate out-of-state.

Then...they will come for the residential property owners. After Prop 13 is gone, you will not be able to afford your home.

DANGER AHEAD!

Democrats in Sacramento are working to do away with our right to use the ballot initiative process. to check the power of the ruling party.

We must file legal action to defend the right of citizens to use ballot initiatives to impose fiscal reforms on state and local government. We cannot let them strip us of this constitutional right; our legal action is crucial!

For 107 years, California citizens have had the right to file ballot initiatives to force reform on their government. This cherished right is our ONLY defense against the abuse of power of the supermajority in Sacramento — and it is under attack!

Next week, **California politicians will try to overturn the right of citizens to use the initiative process through a complex legal maneuver called “quo warranto.”** (no bill from legislature needed...they file a writ in court and have the court rule in their favor)

We already saw California politicians change the title on the Prop 6 Gas Tax Repeal Initiative to mislead voters and defraud them of an honest election. Now they want to **eliminate the citizens’ initiative right for ANY measure that impacts pay or benefits for government employees.** This is only the start. If successful, they will take away our right to any initiative on the ballot.

This outrageous attempt to strip citizens of their constitutional right of ballot initiatives can be **stopped IF we file a counter-lawsuit in state court**. If no one files suit, their legal maneuver will be approved and our rights will be overturned.

Carl De Maio and Reform California, are working to challenge this unconstitutional power grab. They need to file in the next two weeks.

Please read their request and help if you can. This is serious! Socialism in action!
We MUST fight back and we must defend the citizen's initiative rights.
