For Trainer and Coach “Signature”, you can write in “Will sign at Show” and Jamie will sign when she checks in at the Show.

For Show Form payment, either enter your Credit Card information or attach a check (payable as the Show indicates).

Note about Credit Card payments: The Show will usually add a Convenience Fee to Credit Card payments when you check out. **To avoid the Convenience Fee, switch to payment by Check at the end of the Show when you check out.**

Mail in your Show Form before the “Entries Close” date. You can still enter after the “Entries Close” date but you will pay a late fee on top of the customary stall fee.

**BRING ALL OF YOUR HORSE AND RIDER PAPERWORK TO THE SHOW JUST IN CASE THEY LOSE YOUR FORM OR DO NOT HAVE NECESSARY INFORMATION ON YOUR HORSE.**
