# Marysville Township MONTHLY BOARD MEETING Monday June 28th, 2021

**Meeting:** The meeting was called to order by Chair Joe Hickman at 7:00 PM. Members present: Joe Hickman Chair, Jane Hurley Vice-Chair, Andrew Hirsch Supervisor, Debbie Uecker Clerk-Treasurer, Marty Randall Deputy Clerk-Treasurer, Ron Boehlke Road Maintenance and 4 residents.

**Meeting Minutes:** A motion to accept the May 24th, 2021, Meeting Minutes was made by Jane Hurley, 2nd by Andrew Hirsch and carried 3-0.

**Treasurers Report:** The beginning balance for June 2021 is \$147,594.57 receipts of \$335,304.61, expenses of \$89,050.34 and ending balance of \$393,848.84. A motion to accept the Treasurers' report was made by Jane Hurley, 2<sup>nd</sup> by Andrew Hirsch and carried 3-0.

#### **Old Business:**

- 1) Supervisor Hirsch discussed different culvert types, prices and received a quote from True North Steel of \$25,020.04 for a semi load of culverts, buying directly from True North Steel will still be the cheapest option. Clerk Uecker will pull the culvert purchases from 2019 & 2020 and send it to Supervisor Hirsch and Maintenance Boehlke to figure out what sizes to order.
- 2) Clerk Uecker attended the Wright County Planning and Zoning meeting for Donovan DesMarais' request to move a building entitlement to Chatham Township, although both Townships denied the request Wright County Planning and Zoning approved the request.

#### **New Business:**

- 1) Jeremy Scheuble PID 211-000-224200 & 211-000-224300 is buying the McCarthy Property and has applied for a variance to rearrange existing lot lines to create a 1–21-acre parcel & 1-61.5-acre parcel. A motion was made by Andrew Hirsch, 2<sup>nd</sup> by Jane Hurley to approve the variance for the lot line adjustment and carried 3-0.
- 2) Tim Rowe noise complaint was tabled as he was not present.
- 3) 2021 Clean-up Day report was reviewed.
- 4) American Rescue Plan Act was discussed, and funds will be applied for.
- 5) A motion to renew CD#19878 for a 12-month term at .30% APR was made by Jane Hurley, 2<sup>nd</sup> by Andrew Hirsch and carried 3-0.

## **Business from the Floor:**

- 1) Larry Mohler 220 42<sup>nd</sup> St SW wanted to know why dust control was put down on the roads so early, then his road was graded 2 weeks later, and he lost all the dust control? Discussions were made about 42<sup>nd</sup> Street, the road will need gravel next year. After a rain, road maintenance employees will check the road and try to feather out the gravel to see if that will help bring back the dust control.
- 2) Supervisor Hirsch discussed grading roads, bringing in the sides of the road and Hirsch discussed the different percentage of crowns for roads.
- 3) Maintenance Boehlke discussed the need to use belly dumps to haul gravel in 2022.

- 4) Swing-away mailbox costs were discussed. After doing research it will be cheaper for the Township to order directly from the vendor at a cost of \$42 each versus \$44 each from Wright County and will save employee time and fuel of going to Wright County to pick up. A motion was made by Jane Hurley, 2<sup>nd</sup> by Andrew Hirsch to order 15 swing-away mailboxes directly from the vendor and carried 3-0.
- 5) Discussions were made about a fall newsletter and a different calendar for 2022.
- 6) After discussions a motion was made by Jane Hurley, 2<sup>nd</sup> by Andrew Hirsch to order carbides for the grader from Kris Engineering at an approximate cost of \$1,962.36 and carried 3-0.
- 7) All board members are planning on attending the Wright County Township Officer meeting on July 7<sup>th</sup>, 2021.
