### **Dr. Jeffery Hanson**

**"ARCHAEOLOGICAL SITE CONDITION ASSESSMENT: A TOOL FOR MANAGING AND PROTECTING CULTURAL RESOURCES."**

We all know Dr. Hanson from his recounting of his work with the U.S. Bureau of Reclamation studies of the Buffalo Soldiers at historic Fort Craig in New Mexico. Dr. Hanson's subject at our January monthly meeting will focus on the management and protection of cultural resources.

In Dr. Hanson's words, "I want to give this talk because we have devised a nice method for assessing a suite of risk factors to archaeological sites which singly or in combination, can damage site integrity. We can measure and quantify these risks and provide useful data for site stewards, land managers and private property owners concerned with site monitoring and taking appropriate steps to mitigate these risk factors."


**Dr. Hanson received his PhD in anthropology from the University of Missouri-Columbia and taught in the sociology-anthropology department at the University of Texas-Arlington from 1986-2001.**



More recently he has been an archaeologist for the Mescalero Apache Tribe and the U.S. Bureau of Reclamation. He was also recently a principal investigator for Statistical Research, Inc, a cultural resources management firm in Albuquerque, New Mexico.

Following his retirement he has moved back to the DFW area.

## ARTIFACTS DISRUPT DIG FOR BOERNE'S WASTEWATER PLANT

Boerne's new wastewater treatment plant, already an ultra-pricey budget item, just grew even more costly when artifacts believed to be several thousand years old were discovered during digging operations.

The Boerne City Council on Dec. 13 OK'd a contract with UTSA for \$38,656 to carry out archaeological investigations that are required by law.

That's in addition to almost \$30,000 the council approved for the initial archaeological excavation in November, pegged at \$30,000.

"This is one of those situations where we really don't have a choice," said Boerne Public Relations Coordinator Pam Bransford. "Work would be delayed if the contract is not awarded."

According to the city, the work is required by the Texas Historical Commission because of the age of artifacts that were discovered while the city was digging a new pipeline route.

The artifacts were found near the confluence of Menger and Cibolo creeks. According to UTSA experts, artifacts possibly 8,000 years old have been identified at the site.

"This component has potential to provide information of several aspects of archaeological research, including hunter-gatherer subsistence, mobility strategies practiced by nomadic groups, technological adaptations to changing prey species, and the use of rock-lined cooking features in food preparation," a UTSA document on the matter states.

"Because of these potential contributions to archaeological research and our knowledge of hunter-gatherer adaptations dating back to 8,000 years ago, the Center for Archaeological Research recommended that the deeper archaeological component is eligible to the National Register and should be formally listed as a State Archeological Landmark."

According to the UTSA document, the process the city is undertaking has been expedited because of the time constraints the city is facing in keeping the wastewater plant construction on schedule, and no further archaeological investigation is required.

"These mitigation efforts will occur in a very limited and specific portion of the site; they will serve to satisfy the requirements of the National Historic Preservation Act and the Antiquities Code of Texas, regardless of where else within the site limits additional archaeological remains may be found," said Steve A. Tomka, director of the Center for Archaeological Research at UTSA.

Earlier this year, the City Council approved a contract to build a new plant for \$31 million that will double the city's wastewater treatment capacity.

The wastewater treatment plant, being built on a 12.5-acre tract on Old San Antonio Road, has been stymied previously when bids came in higher than expected.

The City Council had to table the matter while the city's consulting engineers tweaked the project and worked with the low bidder to reduce the cost. Some features, such as an administration building, were eliminated and other cost-saving measures were implemented through a series of change orders earlier this year.


According to UTSA, there is a process that will be followed if human remains are discovered.

"We do not anticipate the discovery of any human remains," the university's document states.

"However, should such remains be discovered, CAR archaeologists will immediately stop work in that area and will notify the Kendall County clerk, the landowner, the sponsor, and the THC to initiate discussions on how to proceed," the document stated. "All handling of human remains will conform to the conditions of the State Health and Safety Code."

Park in the patient spaces (after 5PM) and go past the information booth into the underground parking garage. Turn left down the corridor at the double doors in the center. Proceed down the hallway until you come to room 110.
