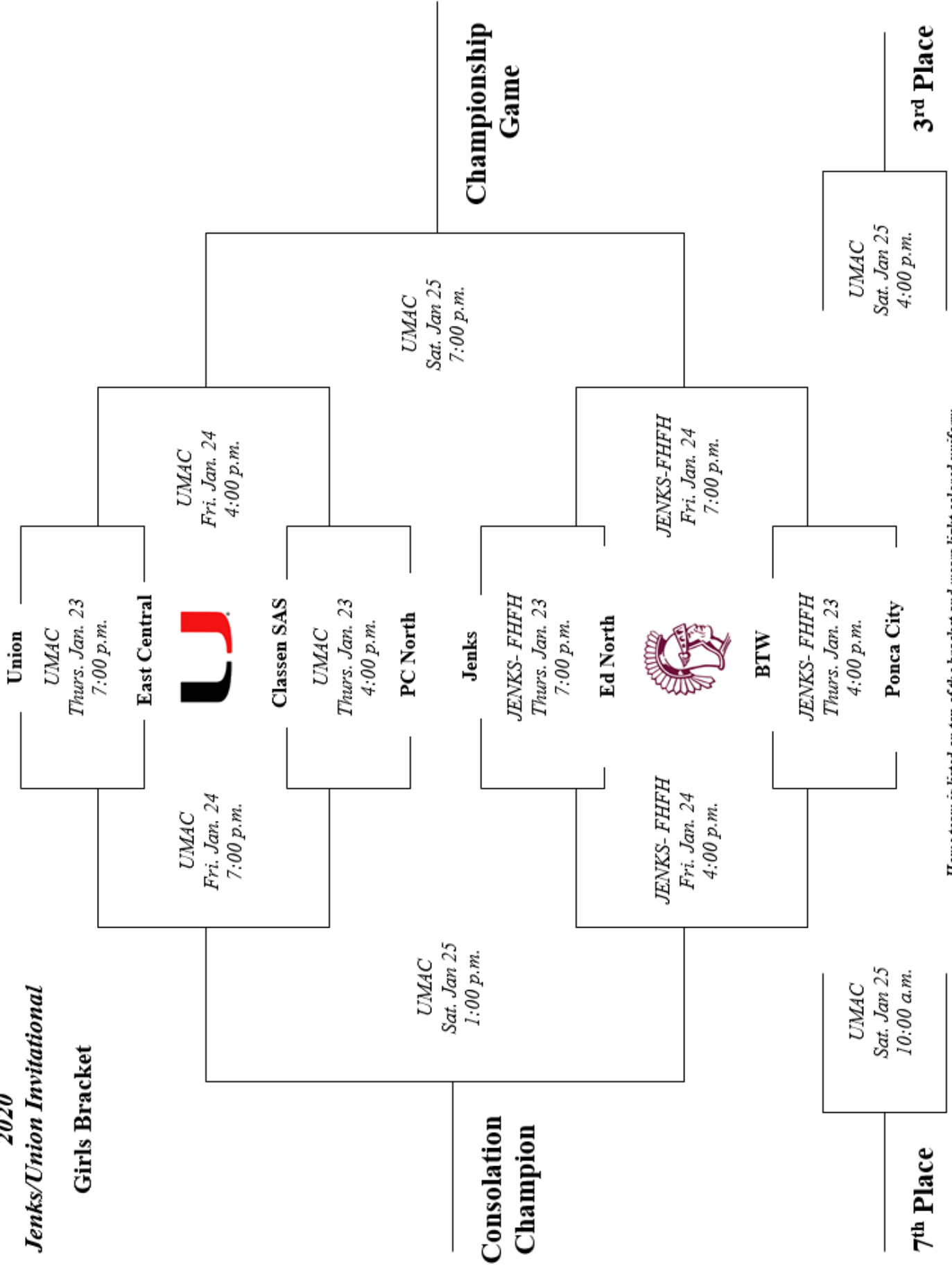

**Girls Bracket**

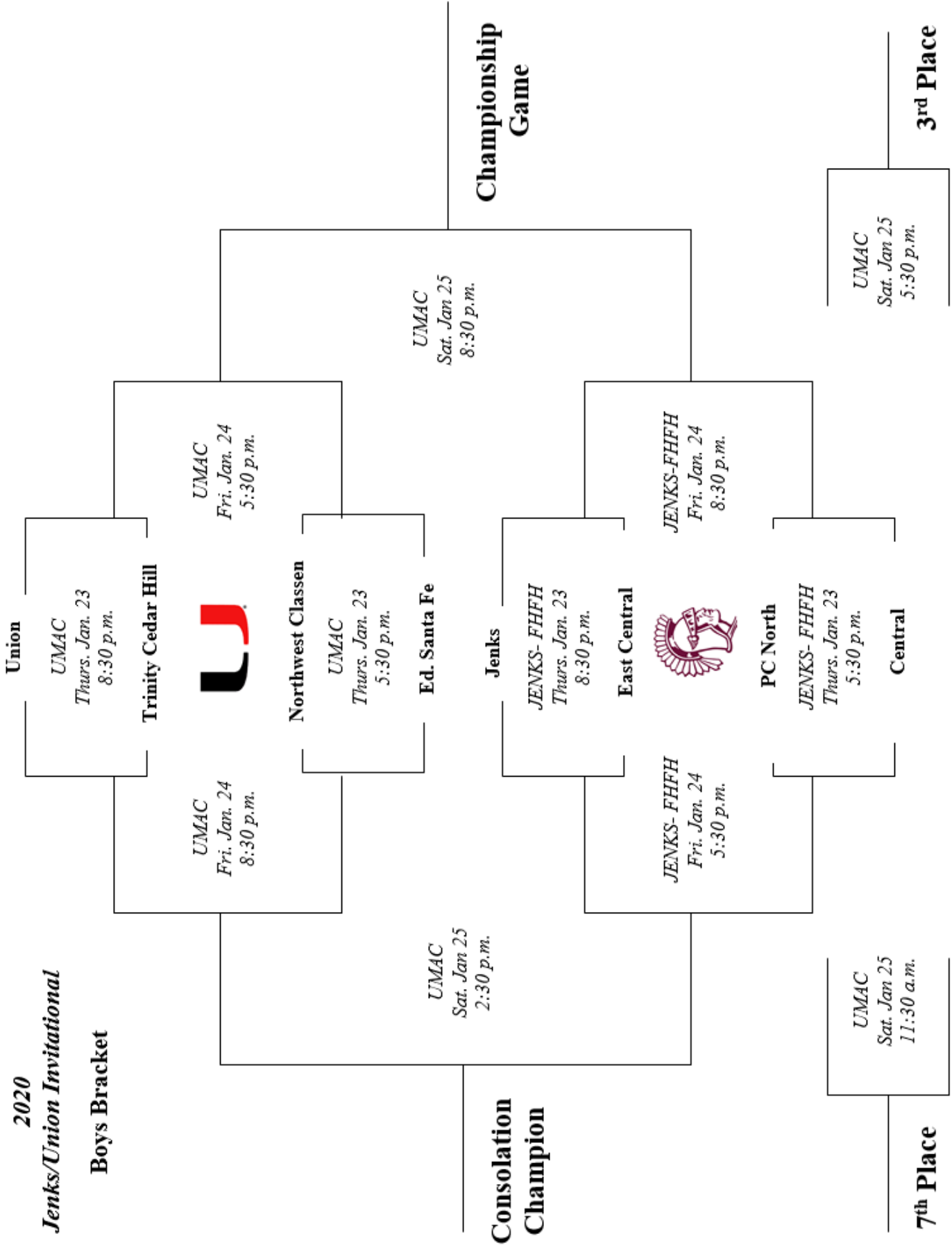

# Emergency Action Plan-UNION

---

This sheltering plan will be utilized when it is necessary to relocate individuals to the safest area. Events that would necessitate the use of this plan would include tornados, inclement weather, hazardous chemical spills or gases released into the atmosphere and other related events. Individuals should be escorted to their designated location and remain there until the all clear sign has been given.

\*All information and evacuation procedures will be provided/conducted by the school administrator, game manager, or head coach on duty.\*

In the event of inclement weather (I.E. Severe Thunderstorm/Tornado **WATCH**) coaches, officials, and athletes will be notified that the Tulsa area is under a watch.

In the event of a Severe Thunderstorm/Tornado **WARNING**, coaches, officials, and athletes will be instructed that the Tulsa area is under a Severe Thunderstorm/Tornado Warning, and proper instructions will be given at that time.

If and when shelter needs to be taken, please use the stairs next to the elevator and move to the field level hallway in front of the stairwell.

ONLY INTERIOR WALLS SHOULD BE USED, REMEMBER TO STAND FACING THE WALL.

Alternative areas include football locker room (field level of UMAC), and basketball locker rooms.

All coaches, officials, and athletes shall remain sheltered until severe weather has ceased or moved from area. School administrator, game manager, or head coach on duty will determine when it is safe to leave sheltered area.

# Emergency Action Plan-JENKS

---

## EMERGENCY PLAN:

### **Life Threatening Injury:**

Parent/Guardian will be contacted by Certified Athletic Trainer (ATC) or appointed individual, if time allows, if not they will be contacted once emergency personnel have arrived and taken over care.

ATC will ask individual to find Athletic Director who will notify campus police, and will radio/call for EMS.

Certified Athletic Trainer (ATC) will administer appropriate care to injured athlete until EMS arrives. First Responders will be met by appointed individual at Southwest doors/Main Entry and will be escorted into building where injured individual is.

ATC or individual providing care to injured person will provide necessary medical information to First Responder/EMS. If parents/guardians are present they will accompany minor in ambulance. If not present, ATC/ school official will accompany minor.

### **Non-Life Threatening Injury:**

Parent/Guardian will be contacted by Certified Athletic Trainer (ATC) or appointed individual. If parents/guardians cannot be reached, emergency contact will be contacted.

ATC will administer appropriate care to injured athlete until parents/guardians have arrived.

Parents/guardians will be given instructions to nearest healthcare facility.
