Before/After Care School Registration 2016-2017

Du Bois Integrity Academy Charter School offers quality Before/After Care Program(s). Our staff will assist the students with their homework, then upon completion of their assignments, students can engage in recreational and enrichment activities.

All fees are designed to be reasonable options for our families. There is a **\$20.00 annual registration fee, per student, to participate in the Before/After Care program(s)**. All families must complete an enrollment form and pay the registration fee prior to a child being accepted into the program. All children **must be signed out by an adult listed on the student contact card or authorized pick up form. After Care personnel cannot legally release a student to any person(s), who is not listed as an authorized contact. Please make sure to complete emergency contact information. They must have the list of names and phone numbers of the people whom you allow to pick up your child/children from school.**

All authorized adults must have picture identification available prior to the release of any child. For safety reasons and legal mandates your child cannot be release without this identification. (Initial) _____

Before Care is available from 6:00 A.M. - 7:15 A.M. Students not registered for Before Care may utilize a daily drop in service for **\$5.00 per day**. Parents must come inside to sign their child in for before care and pay the **\$5.00 daily drop in fee**. Before care drop in is at the side cafeteria door where the Day Care vans drop off and pick up in front of the ne 5th grade modular classrooms. The Before care drop off lane can be accessed from King Road. (Initial) _____

After Care is available from 3:45 P.M. – 6:30 P.M., Students picked up after 6:30 P.M. must pay a \$5.00 late fee for the first minute and \$2.00 for each additional minute. After 6:45 P.M. any student/s remaining in aftercare will be reported to the proper authorities. (Initial) _____

Failure to pay late fees and registration fees will result in your child being dismissed from the DIA After School Program.

All Before/After School Care tuition is due on the Friday before the new week begins. Any tuition not received by 6:30 pm on Monday the week of, will be considered late and will be assessed a late fee of 25.00.

Any unpaid tuition or late fees left unsettled by the Tuesday of the following week will result in your child being suspended from the before care/aftercare program (Initial) _____

Withdrawals or changes in your child's attendance in the DIA afterschool program must be submitted to the front office staff or aftercare directors in writing.

All daily drop in care must be paid on the day the service is rendered.

Before Care Daily rate: **\$ 5.00** per day for daily drop in

After Care Daily rate: **\$10.00 per** day for daily drop in

Weekly for both (**After & Before**) **\$52.00 per week**: After Care (only) **\$40.00 per week**. Before Care per week (only) **\$12.00 per week**. Additional siblings will be **\$35** for the 2nd child and **\$30** for each additional child for aftercare.

Note: If a child attends the program for 2 or more days the full weekly rate will be applied. Before & After Care are only provided during the regular school calendar days.

Days Open/Closed:

The Before/After School Program will be open each day school is in session. In the event of inclement weather the afterschool program may be cancelled.

Daytime Attendance Mandatory:

A student must attend school, and be present at dismissal time, in order to participate in the After School Program

Discipline:

Students are expected to behave appropriately in the Before/After School Program. Failure to do so may result in suspension or dismissal from the program.
