2. Pursuant to *Order Re: Petition No.* 1, the Court approved the Receiver's compensation at the rate of \$250.00 per hour together with all reasonable costs and expenses incurred relating to these services as Receiver. These services are billed by and paid to the Receiver's firm, Simon Consulting, LLC.

3. Pursuant to this Court's *Order Re: Petition No. 1*, the Receiver has engaged the services of the law firm of Guttilla Murphy Anderson, P.C., of Phoenix, Arizona, and the Receiver has agreed to pay the law firm compensation at agreed hourly rates for the services of the firm together with all reasonable costs and expenses incurred on behalf of the Receiver.

10 4. Pursuant to the Court's Order Re: Petition No. 2, the Receiver is authorized to 11 file this fee petition without including as exhibits the itemization of services rendered to, 12 and costs incurred or expended on behalf of, the Receivership, provided that the fee petition 13 includes a statement that anyone desiring additional information concerning the services and 14 costs to be paid under the fee petition may obtain redacted information from the Receiver by 15 delivering to the Receiver and the Receiver's counsel, Guttilla Murphy Anderson, P.C., a 16 written request specifying the additional information requested at least three (3) days prior to the date set for any hearing on the fee petition. The Court's Order Re: Petition No. 2 17 further provides that upon request of the Court, the Receiver shall make available for in 18 19 camera review by the Court the itemized statements and supporting documentation for the services and costs to be paid under the fee petition. 20

5.
