## ASCE, AWWA & HWEA JUNE JOINT DINNER MEETING NOTICE

## Program: Modernizing Hawai'i's EIS Rules

Hawai'i Administrative Rules (HAR) Chapter 11-200, Environmental Impact Statement Rules, were last promulgated and compiled in 1996. Since 1996, the State Legislature has made numerous amendments to Hawai'i Revised Statutes Chapter 343, Hawai'i's courts have issued decisions affecting its interpretation, and the practice and technology of environmental review have evolved. The Environmental Council is undergoing a process to update HAR Chapter 11-200 to modernize and align the rules with statute and practice. The Council will hold public hearings from May 21-31 on each island to gather community input on its proposed draft. Director Glenn will speak about the Council's process and proposed revisions.

**Speaker:** Scott Glenn, AICP, is the Director of the State of Hawai'i Office of Environmental Quality Control (OEQC). The OEQC administers the state environmental review process and provides advice and technical assistance to government agencies, businesses, and community groups. Glenn earned a B.A. in philosophy and classical archaeology from the University of Evansville and a Masters in Urban Regional Planning from the University of Hawai'i.
