For your information, ARTICLE VI OF THE AMENDED AND RESTATED BY-LAWS WHICH BECAME EFFECTIVE JANUARY 1, 2013, states, as follows:

ARTICLE VI. MEMBERSHIP FEE & DUES

SECTION 1. The Board of Directors shall review and approve or deny all applications for membership. A person, corporation or other business entity seeking membership in the Corporation shall make an application and pay the full annual dues upon the acceptance of their membership in the Corporation.

SECTION 2. Each Member, as defined in Article II, Section 2, hereof, or an Associate Member, as defined in Article II, Section 3, hereof, shall be required to pay annual dues for membership in the Corporation. The schedule of annual dues for each class of membership in the Corporation shall be determined by the Board of Directors and shall be published to the membership annually. All dues must be paid by March 1st of the current year. If the dues are not paid by this date, there will be a \$100 penalty assessed in addition to the regular annual dues and voting privileges will be revoked. The Member's name will be removed from the current SDLTA website, until such dues and penalty are paid in full.

SECTION 3. Members in compliance with Article II, Section 2, hereof, holding Certificates of Registration for more than one title plant shall pay full membership dues for each title plant, as determined and published pursuant to Section 2 above.
