**PLEASE READ CAREFULLY BEFORE SIGNING**

**REGISTRATION OF PARTICIPANT AND AGREEMENT PURPOSE:** In consideration of the signing of this agreement, I, the following listed individual and/or the parent/legal guardians thereof if a minor, do hereby voluntarily request and agree to participate in equine instruction, involving but not limited to riding, grooming, leading and any/all other horse related activities, provided by Silver Spur Riding School, Liz Place Performance Horses, Inc., UK Equestrian LLC and Rancho Cielo Equestrian Facility LLC, herein thereafter referred to as THE STABLE. The individual named below, including their heirs, estate, assigns, including all minors, and personal representatives, will herein therefore be referred to as THE RIDER.

_____	THE RIDER agrees that he/she is healthy and physically able to perform all duties related to and involved with horseback riding, grooming, leading, and all other horse related activities offered by THE STABLE. THE RIDER has notified THE STABLE of any/all pre-existing medical conditions that would impair THE RIDERS' ability to participate in any/all activities offered by THE STABLE.
_____	THE RIDER agrees that any/all mental or psychological disabilities, special needs, restrictions or any other mental health concerns have been disclosed to and approved by THE STABLE.
_____	THE RIDER agrees that she is <b>not pregnant</b> and there is no chance of pregnancy, or that THE RIDER physically unable to become pregnant.
_____	THE RIDER understands and agrees that he/she is within our weight restrictions, <b>over 30 lbs and under 220 lbs</b> . Weight restrictions are strictly enforced for THE RIDERS' safety and for the safety of THE STABLES' horses.
_____	THE RIDER agrees to abide by all safety rules/regulations deemed necessary by THE STABLE, whether posted or not posted on premise. THE RIDER agrees to comply by all written or verbal instructions given by all staff or other authorized personnel of THE STABLE.
_____	THE RIDER agrees to wear the required and proper safety equipment: sturdy, close-toed boots with a heel and a certified horseback riding helmet. Bicycle, skateboard, motorcycle, etc. helmets may not be worn. Should THE USER not own the required equipment THE STABLE shall provide THE RIDER with any/all necessary equipment.

**WARNING:** Horses, farm animals and associated farm activities are potentially hazardous. Horses are big, strong, inherently dangerous animals whom are unpredictable. While riding, visiting the premises, and/or engaging in related activities, you might fall, be kicked, bitten, stepped on, or otherwise injured by a horse, cow, goat, pig, cat, dog, fowl or other farm animal. **PLEASE DO NOT SIGN THIS FORM UNLESS YOU ARE WILLING TO ASSUME THE RISK OF INJURY or DEATH TO YOURSELF and/or YOUR FAMILY, GUESTS and/or YOUR/THEIR PROPERTY.**

In consideration of the use of these facilities provided by THE STABLE as a boarder, guest, visitor or rider (all hereinafter referred to as RIDER) for participation in riding or related activities, whether with own horse, a horse provided by THE STABLE or any other horse for the purpose of boarding, equitation lessons, horseback riding lessons, recreational riding, horse shows, horse lease, horse or farm animal viewing, and/or any other horsemanship or horse or farm related activity, the undersigned RIDER or (if under 18 years of age) a parent or legal guardian, intending to be legally bound, hereby waives and releases any and all rights and claims which hereafter may accrue to us, or any of us, against THE STABLE for any injury and/or property damage which may be sustained or suffered by RIDER in connection with such activities occurring on the premises, adjacent property or at horse shows or farm sponsored trips and/or while being transported to or from such events.

This waiver and release is intended to discharge THE STABLE and/or the employees and agents of all of them and each of them, and the adjacent property owners forever, from any liability to personal representatives, heirs and assignees arising out of participation in such horsemanship and/or farm activities, and shall be binding upon the personal representatives, heirs, and assignees of RIDER.

**RIDER** states that he/she understands that **HORSES ARE INHERENTLY DANGEROUS** and is physically able to participate in horsemanship and/or farm activities and is of lawful age and legally competent to sign this Waiver and Release or that this Waiver and Release has been signed on behalf by-parent or legal guardian with whom **RIDER** has discusses his/her proposed activities.

This agreement shall be legally binding upon THE RIDER signing this document on the indicated date and all future dates set forth. This agreement shall be interpreted according to the laws of San Diego County, CA. Any disputes by THE RIDER shall be litigated in and venue shall be San Diego County, CA.
