### **Additional Information:**

#### **Member in Good Standing:**

To remain a Member in Good Standing a member must pay the Membership Fee of \$75.00 payable on or before March 1 of each year. If membership is not received by March 1 the membership will be considered inactive and not eligible to vote at the annual meeting. To continue to be considered a Member In Good Standing, a Member must be current in all required fees
