Topic of the quarter:

Making Online and Phone Meetings Accessible.

Who is Responsible for the Access? The person/Chapter who is setting up the meeting is responsible for creating access to the online/phone meeting. The D/HH participant is responsible for expressing their access needs timely.

Two Ways to Provide Access: Direct access within the meeting itself by streaming in captions or providing interpreters or transliterators. This access appears directly on screen within the meeting itself. Direct access via a third-party access provider (Video relay, text relay, external captioning).

Using Video Conferencing with a Relay Provider: Examples of Video Relay Service (VRS) providers: ZVRS, Purple, Convo, and Sorenson. Examples of Text Relay Service (TRS) providers: Innocaption, Hamilton Relay, Clear Captions, and Sprint Relay. Examples of Voice to Text apps: Otter, Live Transcribe.

Streaming the Captioning Directly in the Zoom Meeting Room:

Closed captioning allows you or another meeting attendee, assigned by the host, to add closed captioning in a meeting. In a webinar, closed captioning can be typed by the host, co-host, or a panelist assigned by the host. You can type the closed captions directly via Zoom or you can integrate a third-party service

- Using Captioning with Zoom: You can add Otter.ai to your Zoom meetings to live transcribe (and also save as notes).
- Skype and Google Meet have an auto-caption feature that you can turn on. Teleconference Meetings: Teleconference or phone meetings can be accessed using Video Relay Service
