LOGGING SHOW RULES AND REGULATIONS

DOUBLE BUCKING

- ◆ CONTESTANTS MAY WEAR CAULK BOOTS ONLY. (**SPIKED TENNIS SHOES, SPIKED HIKING BOOTS, SPIKED GOLF SHOES, OR ANY OTHER SPIKED SHOES WILL NOT BE ALLOWED.**)
- ◆ CONTESTANTS WHO CHOOSE TO WEAR CAULK BOOTS MUST WEAR THEM FOR THE ENTIRE COMPETITION, NOT JUST THE DOUBLE BUCKING CONTEST.

STOCK SAW

- ◆ SAW MAY NOT BE MODIFIED BEYOND WHAT THE MANUFACTURER WILL WARRANTY. **ANY SAW WINNING THE STOCK CLASS IS SUBJECT TO BE CHECKED BY A MECHANIC OF OUR CHOOSING AND COULD BE HELD FOR UP TO TWO WEEKS TO COMPLETE THE INSPECTION.** IF THE 1ST AND 2ND PLACE FINISHERS REFUSE THIS INSPECTION THEY WILL BE DISQUALIFIED AND THE PLACES ADJUSTED ACCORDINGLY
- ◆ CONTESTANTS CUTTING MORE THAN A 2" ROUND WILL BE DISQUALIFIED.
- ◆ CONTESTANTS WHO DO NOT SAW OFF A COMPLETE ROUND WILL BE DISQUALIFIED.
- ◆ CONTESTANTS MAY NOT RUN A SAW MORE THAN TWICE DURING ANY COMPETITION.

MODIFIED SAW

- ◆ MODIFIED SAW MUST HAVE STARTED ITS LIFE AS A CHAINSAW AND RUN ON GASOLINE.

AX THROW

- ◆ ONLY THE LEADING EDGE OF THE AX WILL SCORE.
- ◆ NEITHER CONTESTANTS NOR JUDGE MAY TOUCH AX IN THE TARGET UNTIL CONTESTANT AND JUDGE AGREE ON THE SCORE. A THIRD PARTY MAY BE CALLED IN IF AGREEMENT CANNOT BE REACHED.
- ◆ SCORING IS AS FOLLOWS: BEER CAN 6 POINTS, COLORED RING CLOSEST TO BEER CAN 5 POINTS, NEXT RING 4 POINTS, NEXT RING 3 POINTS, NEXT RING 2 POINTS, AND OUTSIDE RING 1 POINT.
- ◆ BEST THREE OUT OF FOUR THROWS.

NAIL POUNDING

- ◆ LADIES ONLY
- ◆ ONLY NAILS POUNDED COMPLETELY INTO THE LOG WILL COUNT.
- ◆ BENT OVER NAILS DOES NOT COUNT.

NO LOGS USED WILL BE DEBARKED, THIS IS A LOGGING SHOW AND LOGS COME WITH BARK.
