

## Membership Agreement

**CampOut** is a private campground and event center for women. To remain a private campground, all that use the property are required to become members. CampOut will be open 7 days a week from April 1 – October 31<sup>st</sup>.

### Memberships (per person) are as follows:

- A. **\$25 Occasional Use Camping Membership** = mailing list, may purchase tickets for special events. Day/Camping fee = \$5 per day/per person, Cabin fee = \$15 per day/per person.
- B. **\$60 Frequent Use Camping Membership** = mailing list, may purchase tickets for special events. Day/camping fee = FREE. Cabin fee = \$15 per day/per person.

### Memberships are for 1(one) season

- 1. Membership fees are non-refundable.
- 2. Membership fees will remain constant throughout the specified term of the membership. Renewal notices will be mailed. CampOut season is from the 1st of April to the 31st of October.
- 3. For initial membership to be valid, a signed membership agreement is required and dues are payable in full.
- 4. CampOut reserves the right to terminate the membership if the policies and/or terms of the agreement are violated.
- 5. Membership will terminate automatically if the appropriate membership dues have not been paid on or before the specified anniversary date.

### Policies

- 1. Camping space is first-come, first-served. No permanent tent sites.
- 2. At no time will any person or group occupy the campground or cabins for longer than 7 consecutive days.
- 3. Open fires are only allowed in the main fire circle or designated group campsites.
- 4. Smoking is allowed outdoors only. No smoking in any building including the pavilion and porta potties. Memberships will be terminated for illegal drug use on the property.
- 5. Please act responsibly by keeping the land clean. Place cigarette butts in the butt cans, trash in the trash receptacles and utilize the recycling center for glass, plastic, and aluminum cans.
- 6. Use of the lake is at your own risk. There is no lifeguard on duty. One life jacket per person when using boats. Children must wear life jackets at all times.
- 7. **Pets must be under voice control and/or on a leash at all times.** Pets are allowed in the designated cabin. **Pets must be kept quiet and owners must clean up after their pets.**
- 8. **Pets are not allowed during special events.** Service Animals as defined by Title II and Title III of the ADA are welcome. Call or email if you have questions. 804-301-3553 campoutva@gmail.com.
- 9. Pets are allowed to swim at the lake but must stay away from the beach area.
- 10. **Child Policy**: Male children are welcome up to their 6<sup>th</sup> birthday. Male family members and Male children, after their 6<sup>th</sup> birthday are welcome during designated CampOut Family Weekends and must be accompanied by a Member. Female children are welcome and on their 13<sup>th</sup> birthday will be required to purchase a membership.
