"The angel said to them, 'Do not be afraid; for see--I am bringing you good news of great joy for all the people: to you is born this day in

The "old ways," the actions, ideas, and thoughts not of God in our life, will pass away and there will be a new birth of life and love within our heart. "Blessed are the pure of heart, for they will see God" (Mt. 5:8).

With the New Year right around the corner many of may be you thinking of Year's New resolutions. think all of us as Catholic

Daughters should take it upon ourselves to make the New Year's resolution of getting one new member for 2015. Just think if all of us did that our membership at the local and state levels would double.

With new members in mind, I would like to discuss a little bit about leadership and new members. Leaders are volunteers and they can't do it alone; they need helpers who are also volunteers. Believe it or not, those people are all of us. You may not think of

yourself as a leader (because you are not an officer of your court) but you are.

Being a leader or a volunteer takes energy – so we have to be careful of energy leaks; such as angry words, distractions, or tampering in someone else's business while neglecting our own. Leaders must therefore be aware that their energy is subject to depletion and they must make guarding that energy reserve a priority. A way to help restore or bring up that energy reserve is to bring new members into your court, become more active yourself, or getting others more active.

All of us need to take it upon ourselves to try and get new members. We just have to keep asking – we can't let the word "no" get us down. Once we get those new members we need to

plan an orientation program for them and when doing this remember the word **AIM**.

Acquaint your new members to the organization and to other members. Structure time for the members to get to know each other and to develop personal relationships.

Inform new members of your court's history, purpose, and structure. Give them some background information on the organization, its makeup and operations.

Members. Get your members excited about CDA once again. Target the returning members and also the newly recruited. Provide time for them to meet each other, to share ideas and expectations.

Good luck with this and any other New Year Resolutions you may have. I can't wait to see how our courts have grown.

Parliametry Procedure by Angela Scheett

What is parliamentary procedure? It is used to conduct meetings in an orderly manner. According to the Tools of the Trade. "Special Rules of Order may be adopted by National, State and Local Courts of The Order (Catholic Daughters of the Americas) with the approval of the National Board. In all matters of procedure not otherwise provided for by the Bylaws, the current issue of Robert's Rules of Order, Newly Revised, shall be the authority in all branches." Robert's Rules of Order, Newly Revised, provides guidance in the codes of parliamentary procedure. The un-

derlying principles are justice and equality, one thing at a time, rule of the majority, and rights of the majority.

Justice and equality mean that every item of interest has an equal chance to be presented to the group. In addition, each individual at the meeting has a fair chance to offer her comments regarding the item under discussion. This occurs until nothing new is presented and the group is ready to make a decision. One thing at a time is just that; only one item can be under consideration at any one time. As long as there is a topic under discussion,

nothing new may be presented. Once a decision is made about the first item, the meeting can move forward with something else. Rule of the majority and rights of the majority relate to voting on items presented. Everyone has the opportunity to express their opinion, whether they are in the majority or the minority. When the group is ready to make a decision, it is brought to a vote. The majority vote determines the result.

A quorum must be present to conduct a meeting. A Local Court quorum is eight members in good standing, providing a majority of

How can we prepare the way for the Lord? How can I get away from the hustle and bustle of the season? How do I make room for

Jesus? Mary and Joseph went off to a stable or cave, off by themselves, off alone. No space was reserved for Jesus when he came. There was no hospitality, no welcome. There was severe overcrowding in and around Bethlehem, and the local residents and visitors alike were unwilling or unable to receive Jesus when he was born.

The lack of room for Jesus is an age-old problem. There still is severe overcrowding. Our minds are overcrowded with

news and information, our hearts are over-crowded with innumerable concerns, our schedules are

overcrowded with things to do, the malls are overcrowded with shoppers, the highways are overcrowded with traffic, the airwaves are overcrowded with noise, and electronic devices are overcrowded with messages. With so much overcrowding, we run the risk of not having enough room in our personal "inn" to receive Jesus this Advent and when Christmas arrives.

If we want to prepare well for Christmas, it's essential to make room in our hearts to receive Jesus. No matter how busy we may be, no matter how much hustle and bustle may exist, no matter how many distractions and mental preoccupations may swirl about our minds, we need to set aside time and space to welcome Emmanuel, our Savior.

We need to prepare for the Christmas joy. We need to find time to meditate and pray, to converse with our Messiah and Lord in silence and solitude, to ponder the mystery of the Incarnation, to offer hospitality and welcome Jesus. Moments of private prayer are very important. We need to examine our relationship with God as that really is the most important Gift.

There are many prayerful ways to welcome Jesus into the "inn" of our hearts.

Some ways would be to read the first two chapters of Luke's

gospel and prayerfully reflect upon his infancy narrative; say the Joyful Mysteries of the rosary; pray in front of a manger or crib scene at home or at church.

Cont. from pg. 4—Parlimentary Procedure

Officers are present. While meetings can be held without a quorum, no official Court business may be conducted.

Items of business arise in a variety of ways during a meeting. They may already be on the agenda from the Board, assigned Committees, and when the Regent knows she needs input from the members; or they may be offered by a member. These items need to be presented in the form of a motion. There are six essential steps; three by which the motion is brought before the group and three in the consideration of the motion. When a motion is brought before the group, 1) a member makes a motion ("I move that..."), 2) another member seconds the motion, and 3) the Regent states the question on the motion. When it is under consideration, 4) members debate/discuss the motion, 5) the Regent puts it to a vote, and 6) the Regent announces the result of the vote. If there appears to be no disagreement during routine business, time can be saved by using General Consent. The Regent states, "If there is no objection..." and the action she mentions will take place whether it is minutes approved, bills allowed to be paid, or meeting adjourned.

It is important to follow parliamentary procedure so as to have a wellordered meeting where each person can have their say. Everyone also needs to be respectful of one another. This includes allowing others to speak without interruption and listening instead of talking to one's neighbor. That way, all can hear what is being discussed and make decisions accordingly.
