Weekend **GRACH Special: \$50.00-All 3 Levels** for standard classes the **same dog/same trial - Pre-Entry Only.**

Junior Handler entries are \$12.00. Day of Show JR \$15.00

*Entries will run in "B" if no designation in indicated.
Indicate if you run standard or minimum jump height.*
