Mayor: Mayor Edwards addressed a resident complaint that was brought up at the November meeting regarding the tree ordinance. The updated tree ordinance has been codified. The revised ordinance does not allow for the Council to tell people to cut down trees. The Council can have a discussion in which was the case with the resident's complaint, but they are not allowed to force a resident to take a tree down. Also, Edwards stated that erosion issues are the responsibility of the homeowner and not of the City.

Edwards had a discussion with the City Attorney regarding the current snow ordinance. At the advice of the City Attorney, the City sent out a newsletter to notify the citizens of the Snow Ordinance. The

Sheriff has jurisdiction to ask residents to move vehicles parked on the street when the Snow Ordinance is in effect.

Edwards also reported that a newsletter was mailed to all residents.

Finally, Edwards reported that he attended the Emergency Management Budget Meeting. There will not be an increase for services. The next meeting is January 28th in which they will approve the budget.

Streets: The repair of potholes will not be done this year. It may be possible to add them to the Pioneer Drive project next year.

Sewers: No report

Parks: No report

Tree Steward: There is a dead tree hanging over the street at 121 Oakwood Ave. The resident is aware of the situation. Residents at 101 Pioneer will be removing a dead tree that is damaging their property.

Storm Sewers: Norman reported the work on Emerson Hough has been completed. Grass mats have been put down and the curb has been fixed.

a. Humke moved and was seconded by Norman to use Spear Financial for funding of the Pioneer Drive Pavement & Drainage Improvement Project. Motion carried 3-0.
