

**Jefferson City Art Club
2019 Adult Fine Art Exhibit
Entry Information**

(Exhibit at Capital Arts Gallery, 1203 Missouri Blvd., Jefferson City, MO)

The Adult Fine Art exhibit is sponsored by the Jefferson City Art Club (JCAC), Capital Arts Gallery (CA), and the Jefferson City Parks and Recreation Department.

The annual Adult Fine Art Exhibit is scheduled for March 28-May 3 in the Capital Arts Gallery, 1203 Missouri Blvd., Jefferson City, Missouri. (Please note all dates are different than last year). The artists' reception will be April 26, part of the city-wide **Art Around Town Gallery Crawl, attracting over 200 visitors at several different locations.** (See more info about the Art Around Town Gallery Crawl at www.capitalarts.org.)

Entries will be accepted from residents and artists within 100 miles of Cole County. As this is an Adult Fine Art Exhibit, high school and younger artists are not eligible to enter. Pre-entry by mail-in registration is required. See the last page for form. No work will be admitted to the show unless we receive your registration by March 22. All artwork must be hand delivered between 1:00 and 4:00 on March 28, 2019.

Eligibility Classifications:

Professional

- A. Anyone who has earned an art degree in any area of art from a college, university or accredited art school, or
- B. Anyone who earns at least 50% of his/her yearly income from art work, or
- C. Anyone who teaches art classes for reimbursement, or
- D. Anyone attending graduate school in art. **(Once Professional, always Professional)**

Amateur

- A. Anyone who has had formal training of art study in a college, university, art school or accredited correspondence school, but who has not attained any of the levels mentioned for professionals, or
- B. Anyone self-taught or having had limited training only through workshops or community art classes.

The Adult Fine Art Exhibit Committee may determine eligibility.

Entry Rules:

1. Entry fee \$7 per entry Jefferson City Art Club members only (not Capital Arts members), or \$8 for others. Limit of 4 entries per artist. Entry forms are due by March 30. JC Art Club membership is **\$25/yr.** and may be paid now with this entry form and a membership form from <http://www.jeffersoncityartclub-missouri.com/> if joining.
2. Artwork must be recent and never shown previously in Capital Arts or Adult Fine Art Exhibits.

3. **Art must be original in design and execution by the registered artist. No copying of printed or manufactured items (except in collages where up to 10% may come from printed or manufactured sources.) The use of other artists' work is prohibited. All artwork must be hand produced. No computer-generated art or electronic enhancement except in the Photography B field. Photography A entries may only have computer changes that could be done in a dark room.**
4. Artwork must remain in gallery for duration of show.
5. Artwork and frames must be completely dry.
6. All 2 dimensional artwork must be framed, except gallery wrapped canvas with painted edges. Wire hangers only, no saw tooth or loop hangers. Maximum size 48 inches in width and/or height.
7. Art must be for family viewing and adhere to Capital Arts Gallery policy; no partial nudes, nudes, graphic violence.
8. Sculpture must be clay, metal, glass or wood, and decorative only.
9. Capital Arts will retain 25% commission on sales to support the mission of CA with payments made to the artist after the show.
10. Telephone and email contact information must be on entry form.
11. To promote yourself and your work, please submit images of your work by mailing CD to CA or email JPEG files to artsadmin@capitalarts.org. These images will be posted on the CAG website. Optionally you may bring your Artist Biography page for Bio book when you drop off your art. It should be one page typed with images if desired.
12. CA and JCAC will do its best to display artwork in a complimentary fashion. We appreciate your suggestions, but reserve the right to hang the exhibit as we see best.
13. No refunds will be issued.
14. All entries are checked for meeting entry requirements, proper classification and entry field on the tag. Any artwork not meeting entry requirements will be **rejected**. Entry field may not be changed unless deemed necessary by committee.

Additional Information:

Artist assumes complete responsibility for insurance of artwork. All reasonable care will be given to artwork in custody of the Jefferson City Art Club and Capital Arts Gallery. Works submitted are at the artist's risk. The Jefferson City Art Club, Department of Parks and Recreation, and Capital Arts Gallery do not assume responsibility for damage or deterioration incurred before, during or after the exhibition. Submission of any entry in this exhibit constitutes agreement from entrant to the conditions above. All artwork for sale is eligible for Purchase Prize Awards. If not for sale, so indicate on entry form.

Judging and Awards:

Judge is a qualified individual familiar with all classifications and judging is closed to public. Ribbons are given in each field within each classification for, 1st, 2nd, 3rd place and Honorable Mention. Cash prize of \$100 and a ribbon is given to one Best of Show winner in Professional, and one Amateur winner. People's Choice Awards- for each classification will be voted on during entire show. People's Choice ribbon will be given at end of show. A special award will be given to a Watercolor piece in each Classification in celebration of long-time member and past president and well-known watercolorist Florence Guhleman. Winners will be announced on the CA and JCAC websites and to public.
