- 1. Entries must be in by the closing date listed on the website for each show. Post entries may be accepted with a \$20 late fee at management's discretion. Combined Test show dates listed below:
 - 1. May 23, 2021
 - 2. July 11, 2021
- 2. Physical address for the horse shows is:

- a. Entries may also be mailed to this address
- b. Trailers should enter the Southern driveway
- c. Trailers unloading for stalls may not block the driveway. A driver is available for help with backing or parrel parking trailers. Trailers have 15 minutes to unload and then proceed to the parking lot.
- d. ALL PARKING IS IN THE BACK OF THE PROPERTY. Cars parked at the house, apartment, barn or handicap spaces will be given a warning over the loud speaker and then towed.
- e. Vehicles entering and exiting the property should not be traveling over 5mph at any point. 1 warning will be given and then speeding drivers will be asked to leave the property.
- 3. Formal attire is suggested in both arenas. Half chaps are allowed. Competitors may compete without a jacket. In such cases, shirt long or short sleeved with a collar and without neckwear, of a conservative color, neatly tucked into riding breeches.
- 4. Stalls are available on a first come, first serve basis, and must be paid for in full. NON-REFUNDABLE FOR ANY REASON UNLESS THE SHOW IS CANCELED BY MANAGEMENT. Bookings for stalls are not final until payment has been received in full. No tack stalls.
- 5. NO SMOKING ANYWHERE ON THE PROPERTY AT ANY TIME. VIOLATORS WILL BE REMOVED FROM THE PROPERTY IMMEDIATELY.
- NO DOGS OR ANY OTHER ANIMALS. VIOLATORS WILL BE REMOVED FROM THE PROEPRTY IMMEDIATELY.
- 7. Food vendor will be available. Food tickets may be purchased on entry form in addition to regular payments.
- 8. All vaccines must be administered by a licensed veterinarian with professional paperwork. Over the counter vaccines will not be accepted by management. All horses entering the property must have proof of the following prior to unloading or will not be allowed to remain on the property.
 - 1. Coggins must be dated after January 1, 2019
 - 2. Rabies vaccines must be within 1 year of the show date
 - 3. All horses entering the property must have proof of Rhino/Flu vaccine no exceptions

- 9. Jump rounds will be unlimited if PRE-ENTERED. You may enter as many times as you wish. Please put a quantity next to your entry marker.
- 10. There will be a blocked time at the end of each jump height for same day entries. This block will available on a first come, first serve basis.
- 11. The dressage ring will be SMALL SIZE (20Mx40M).
- 12. Dressage only section may pick their tests from the USEA website. Small ring format only, www.useventing.com
- 13. Warm up will be held indoors.
- 14. Jump ring will be available for a 10 minute FLAT ONLY warm up before each height.
- 15. Show jumping will be in an outdoor sand arena
- 16. Riders will ride dressage before their show jumping
 - 1. There are no warm up rounds. A rider's first dressage test and first jump round will be their combined test entry
- 17. No ribbons will be awarded for entries that are jump round or dressage only. Ribbons will only be awarded for combined test entries.
- 18. All entries must be paid in full and have all required health paperwork to be considered "complete".
 - 1. Checks can be made out to "City View Equestrian, LLC"
 - 2. Venmo payments can be sent to @cityviewseries (Please include rider name and horse name)
- 19. Riders late to the ring will be disqualified and receive no refund
- 20. Jump ring will run CONSECUTIVELY with the dressage arena
- 21. Divisions will be run in this order:
 - 1. Green
 - 2. Starter
 - 3. Beginner Novice
 - 4. Novice
 - 5. Training
- 22. Times will be posted on www.cityviewequestrian.com and the Show Series Facebook Group.
- 23. NO BULLYING ALLOWED AT ANY TIME. ANY COMPETITOR, TRAINER, OR VISITOR CAUSING HARM OR DISTRESS ON THE CITY VIEW PROPERTY WILL BE REMOVED IMMEDIATELY AND BANNED FROM FURTHER SHOWS
