	Vendor Space Consignment Base(s): Fee Rate: 30% per transaction. Taxes are withheld from Final Payment Monthly. Credit card fees are at 3% and are transferred to the customer (as long as our system allows this), we will make every effort possible to not transfer the 3% transaction fee to you, however if this changes we will let you know.
	Vendor Booth Space(s): Fee Rate: \$2.50 Sq. Foot PLUS 10% per transaction. Taxes are withheld from Final Payment Monthly. Credit card fees are at 3% and are transferred to the customer (as long as our system allows this), we will make every effort possible to not transfer the 3% transaction fee to you, however if this changes we will let you know.

Consignee represents that they are solely and individually entitled to enter into this agreement with respect to all items they will place and sell within Wags 2 Wishes Resale. Consignee further represents that at the time of entering into this contract with Wags 2 Wishes Resale and at all times in the future they (the Consignee) are the true and lawful owner(s) of all items they represent and transact as for sale, have obtained said items by lawful means, solely have the legal right to authorize sale of said items, and that the items are free and clear of any and all liens, mortgages, security interests or other encumbrances.

Consignee further agrees to hold harmless and indemnify Wags 2 Wishes (Resale), its owners, managers, agents, and employees harmless and free from any liability and or responsibility by misrepresenting the above, including but not limited to all demands, claims, suits, judgments, or other liability asserted by or awarded any person or entity arising by reason of Consignees ownership, possession and/or sale of any or all items. Wags 2 Wishes (Resale) offers no facilities for cleaning, storage, restoration, or processing of Consignees items. At any time items owned by a Consignee are found outside of contracted booth space these items will be relocated to the Consignees contracted booth space or at the discretion of Wags 2 Wishes (Resale). From time to time Wags 2 Wishes (Resale) and its agents, employees, and representatives may phone the booth renter (consignee) to present offers made by customers to buy items contained in dealers (booth renters) booth and offers indicating a discounted rate off the listed item will require booth renter (consignee) expressed consent. Wags 2 Wishes Rescue (Resale) is not responsible for theft or damage that may occur being inside our building. You are encouraged to keep delicate items out of the reach of a potential "leg lifting" by a dog. This is a dog rescue after all.

Wags 2 Wishes Rescue (Resale) may change any and or all terms of this agreement by informing Consignee of said change and date said change will become effective. Furthermore, Wags 2 Wishes Rescue (Resale) may elect to terminate this agreement with the consignee at any time without reason or cause.

If such termination of agreement is enacted consignee shall have 7 calendar days to remove items from the booth space and premises. If we deem a product (your products) are not selling at the shop you will be asked to remove the items so we can bring in other products that may have a greater chance at sales. At any point upon the completion or termination of the consignee / booth space relationship the consignee agrees that if items have not sold they will pick the items up or arrange for pick up at their own expense within 7 days of being notified.

- POST ON SOCIAL MEDIA Take photos and share with your friends and family, direct them to the store! Offer discounts or incentives for sharing or visiting. This is the easiest way to market and its FREE!
- Dust, Clean, and Rearrange. Merely repositioning your items in your booth will draw attention and increase sales.
- Do not dismantle your booth or block access to your booth or the spaces around it on heavy traffic days such as Saturday or Sunday. These are high traffic and high volume sales days.
- All booth in takes must occur during slow times or an hour before closing no intake of large items should occur on Saturday or Sunday.
- All items in your booth need to be clearly priced with your vendor info on the tag. Wags 2 Wishes (Resale) will not make phone calls to inquire about prices.
