_____ My dancer will attend all dance classes consistently and will put forth an honest effort to know choreography for the 2019 recital. I understand that group/class choreography will only be successful if **all** students are committed and attending class regularly. (If we miss for illness or unforeseen circumstances, I will make every effort to do make up classes to be consistent in improving my overall dance technique.)

_____ My dancer/s will be at all rehearsals and performances. Pictures will be on **Wednesday June 5th** at MCDA studios. Tech Rehearsal will be on **Thursday June 6th** at Highland High School, (Exact times for each class - will be announced in late April. Dancers will only need to be there for their classes' time slot) Dress Rehearsal will be **Friday June 7th at 5pm** at Highland High School. Performance on **Saturday June 8th at 2:00pm**. *All rehearsals and performances are mandatory for all participants.*

_____ I understand that each class is performing as a group & a missing dancer would be unfair to the rest of the group working to give their best performance.

_____ I will be responsible for the expense of costume, tights, & shoes needed to participate in the recital. Ticket orders forms will be **due by March 23rd**. Tickets will be distributed in early May . If you do not purchase your tickets during the ticket order period, you will have to purchase tickets at the door for the higher price. Pictures and video will be an additional cost, if you choose to purchase them. All items are final sale.

_____ **Costume fees are non –refundable** and I will be responsible for all costume balances once I have committed to participation in the 2019 Recital "**Lights Camera DANCE**". Even in the event of illness, moving or withdrawing for any reason I will pay for the costumes I order. **Costumes are final sale.**
