# Summer Program Agreement

## Fee Schedule

A registration fee of **\$45.00 (per child)**, as well as one week's tuition payment, is due prior to enrollment. The remainder of tuition, including the 1st week's activity fees, will be billed in 2 equal payments. Payments will be **due May 17th (Summer Orientation) and June 20th.**

Activity fees should be included with your tuition amount listed below. These activity fees will be assessed during orientation. Activities are subject to change due to weather, availability, etc. We will notify you of any changes prior to scheduled activity. For your convenience, we accept personal checks. However, we have the option at any time to refuse any further payment by check. All checks should be made payable to LIVE AND LEARN ACADEMY and need to be placed in the drop box or in your child's lunchbox (preschool campers).

# Summer Camp Agreement / Authorization

LIVE AND LEARN ACADEMY requires a \$45.00 non-refundable Registration Fee (per child) as well as one week's tuition payment (per child). *\*\*\*The \$45.00 Registration Fee is non-refundable unless placement is not available for your child. If you should choose not to attend camp, the 1st week is refundable prior to May 17th. No refunds will be issued after May 17th. The Registration Fee(s) and 1st weeks payment are due at the time of registration.*

LIVE AND LEARN ACADEMY's Summer Camp is based on a 7 week program. Tuition will be billed in two (2) equal payments, which includes activity fees. Payments are due May 17th (at Summer Orientation) and June 20th. All checks should be made payable to LIVE AND LEARN ACADEMY and need to be placed in the drop box located in the office.

Parent Initials Tuition is due on the 20th of each month, and will be considered late on the 21st. There will be a late charge of 10% of the balance owed. If the balance is not paid in full by the 25th day of the month, your child's space may be forfeited. Tuition and activity fees are non-refundable.

Parent Initials All checks will be made payable to LIVE AND LEARN ACADEMY and should be placed in the drop box. Preschool parents can put their payment in their child's lunchbox. There will be a charge of \$25 for all returned checks. We have the option at any time to refuse any further payment by check.

Parent Initials A late pickup fee of \$10 for the first 5 minutes and \$1 per minute thereafter will be charged after 1:00PM for half day care and after 6:00PM for full day care.

Parent Initials Activities are subject to change due to weather, availability, etc. If it is necessary to change a scheduled field trip, the staff will post the changes on the door and leave a recorded message on the LIVE AND LEARN ACADEMY telephone.

Parent Initials If additional days are requested, additional tuition / activity fees will be assessed and due prior to the days requested. I understand there will be no refunds or credits issued for days/weeks my child does not attend.

Parent Initials I grant permission to the staff of LIVE AND LEARN ACADEMY to transport my child off the school property for field trips. I understand that this applies only to children over the age of 30 months and all children will be properly secured in appropriate child safety seats.

# Summer Camp Rules and Guidelines

## Drop Off and Pick Up

- Please be sure to arrive on time. Drop off for Preschool Camp is **9-9:15am**. School age children can be dropped off beginning at **8:30am** and no later than **8:45am**, to avoid interfering with preschool drop off. Children who arrive after their group has departed will NOT be permitted to stay at LIVE AND LEARN ACADEMY. We will not wait for late arrivals.
- Preschool Campers will be loaded and unloaded by a LLA staff member beginning at 9am for drop off and 12:45 for pick up. School Age parents will need to check your child IN and OUT with the staff member in their room when dropping off and picking up. This will ensure the safety of the children and ensure our attendance sheet is kept accurate.
- Preschool pickup begins at 12:45pm and ends at 1:00pm. If you are arriving after 1pm, you will need to come in to the school to pick up your child and pay the late pickup fee. School age children need to be picked up no later than 6pm. A late pick up fee of \$10 for the first 5 minutes and \$1 a minute for every minute after will be charged after 1:00PM for half day and 6:00PM for full day.

## What to Wear for Field Trips / Water Days

- Wear LLA Summer Camp t-shirts on our field trip days (Mondays and Wednesdays for 4', 5's) (Tuesday, Thursday for School Age).
- Preschool campers should wear their LLA bathing suits (with cover up) and water shoes to school on water days. Please be sure to send a beach towel (labeled w/ their name) and a dry change of clothes.
- School Age campers need to bring their LLA bathing suits each Monday/Wednesday/Friday. Campers need to bring a beach towel (labeled w/their name).
- Campers need to wear tennis shoes or closed toe shoes. School age campers will need to wear tennis shoes even on pool days but should bring water shoes or flip flops to wear to the pool.

## General Guidelines

- All campers need a water bottle (labeled with their name) EVERY DAY.
- Please send cold lunches only. Lunches should include any utensils needed.
- We recommend applying sunscreen and insect repellent before arriving to the school. We ask that each parent send in a bottle of each per child to be left at the school. If your child has sensitive skin or you prefer a specific brand, please label your bottle with your child's name. We will reapply sunscreen and bug spray as needed throughout the day.
- Summer tuition will be due in 2 equal payments (May 17th & June 20th). LIVE AND LEARN ACADEMY will not issue any refunds or credits after for weeks not attended. See your contract for amounts. There will be a late charge of 10% of the balance owed if balance is not received by the 20th of each month. If the balance is not paid in full by the 25th, your child's space may be forfeited.
- LIVE AND LEARN ACADEMY is not responsible for personal items brought to camp (i.e. cell phones, Ipods/Ipads/Kindles, toys, etc.)
