Mayor Davenport encouraged everyone to be careful with the new Coronavirus variants.

The second reading of Ordinance 2022-001 regarding Sewer Installation, Connection and Use was conducted by Mayor Davenport. Council member Mothershed asked for clarification regarding the wording within the policy which was answered and explained by Sewer Operator Steve McDonald.

A motion to approve Ordinance 2022-001 regarding Sewer Installation, Connection and Use policy was made by Council member Goodwin and seconded by Council member Mothershed. The motion carries (4-0-1 abstention).

The first reading of the revised Police Department Policy #17 regarding Extra-Duty, Off-Duty or Secondary Employment was read by Mayor Davenport. Second reading and vote will be held at next month's Council meeting

Resolution 2022-05-003 for the "Sales Tax Holiday" was introduced by Mayor Davenport. Motion to forgo with reading Resolution 2022-05-003 was made by Council member Reed and seconded by Council member Stepney. The motion carries (5-0). Motion to approve Resolution 2022-05-003 as presented was

Mayor Davenport stated that the Town had put together a plan for the pecan orchard project in order to apply for the Land and Water Conservation Fund grant. Mayor Davenport went over the recommendations received and the proposed cost estimates. The design was on display.

Resolution 2022-05-004 for the Pecan Orchard Park ADECA/Land and Water Conservation Fund Grant application was read by Mayor Davenport. A motion to approve Resolution 2022-05-004 as read was made by Council member Reed and seconded by Council member Stepney. The motion carries (5-0).

Resolution 2022-05-005 for "Phase 1" Extension of the Sewer Line was read by Mayor Davenport. Motion to approve Resolution 2022-05-005 as read was made by Council member Goodwin and seconded by Council member Reed. The motion carries (5-0).

Resolution 2022-05-006 for the Municipal Water Pollution Prevention Program was introduced by Mayor Davenport. Motion to forgo with reading Resolution 2022-05-006 due to the annual renewing of this resolution was made by Council member Goodwin and seconded by Council member Stepney. The motion carries (5-0).

Motion to approve Resolution 2022-05-006 was made by Council member Goodwin and seconded by Council member Stepney. The motion carries (5-0).

Next item of business was the introduction and approval of the purposed budget for the 2nd tranche of ARPA Funds. Funds are due in the month of June. Motion to approve the purposed budget for the ARPA Funds was made by Council member Goodwin and seconded by Council member Reed. The motion carries (5-0).

At the April regular meeting of the Planning Commission there was a request to build a 12,000 square foot retail business in the Downtown Historical area. After having heard from the public at 2 meetings and given the cost to the Town it is the unanimous recommendation of the Planning Commission that this proposal NOT be allowed at this location.

A motion to accept the recommendation of the Planning Commission and so move that the proposed development at the corner of Kowaliga Road and East Collins NOT be allowed at this location was made by Council member Goodwin and seconded by Council member Stearns. The motion carries (5-0).

Mayor Davenport then asked Council to entertain the idea that the Town spear-head the purchase of this property allowing it to regulate the development so that this location might remain true to its historic nature. He went on to state that several individuals are interested in portions of the property but the family would like to sale it as a whole. Council asked for a meeting to be set with the interested parties and letters of intent be signed. The issue was tabled until such time more details could be worked out.
