- **New GRCA Rule: WC/WCX entries for Golden Retrievers must now include photocopy of dog's registration form.**
- At the judges' discretion, wingers may be used in the WCX test.
- WCX will be judged first, to be followed by WC.
- Pheasants to be used on land; ducks on water.
- A complimentary lunch will be provided by NFGRC for all test participants and workers.
- Rosettes and duck bands will be awarded to all dogs qualifying in each stake.
- BITCHES IN SEASON SHALL NOT BE ALLOWED ON TEST GROUNDS.
- Refund of entry fee, minus \$5.00 will be made for bitches in season and dogs unable to run due to illness or injury, with written certification by licensed veterinarian. Must scratch by 8:00 am.

Directions to Webshire Kennels

From Hwy 41 (Milwaukee/Oshkosh): From Hwy 41, just over the lake, take the Hwy 45N exit. Follow 45N for 12 miles to County Rd II exit. Turn left onto CR II and go past the Kwik Trip to Mud Creek Rd. Turn left onto Mud Creek Rd and follow 1 mile to Grandview Rd. Turn right onto Grandview Rd and follow 0.8 miles and watch for signs. Webshire address is 5694 Grandview Rd. Larsen, WI.

From Hwy 41 (Appleton): From Hwy 41 take the Hwy 441/10 exit and follow Hwy 10W for 10.6 miles. Take the Hwy 45S exit (left lane) toward Oshkosh. Once on Hwy 45S, immediately get into the right lane and take the County Rd. II exit. Turn right onto CR II and go past the Kwik Trip to Mud Creek Rd. Turn left onto Mud Creek Rd and follow 1 mile to Grandview Rd. Turn right onto Grandview Rd and follow 0.8 miles and watch for signs.

From Waupaca/Hwy 10: Follow Hwy 10 to Hwy 45 South. Exit Hwy 45 south onto Cty Rd II and turn right. Then follow the directions above from Appleton.
