A RESOLUTION OF SUPPORT FOR THE APPLICATION OF THE VILLAGE OF RUSSELLS POINT FOR CLEAN OHIO FUNDS FOR THE INDIAN LAKE-GREAT MIAMI RIVER RIVERSIDE TRAIL EXTENSION AND RIVER ACCESS RAMP PROJECT AND DECLARING AN EMERGENCY.

Discussion: It was confirmed that the canoe input is included in the grant application however it has not been determined if such input will increase the village's liability insurance. Some council members noted reservations and may have more questions prior to final acceptance of a grant award.

Ms. DeVault asked if council was going to place the police levy on the next ballot at a 1.5 mil as previously discussed. The necessary resolutions need to be passed and submitted by February 1, 2017 to meet the Board of Election deadline for the May primary.

OLD BUSINESS:

A. LMI Survey

After the initial review of those surveys received, it was determined that the Village did not meet the minimum requirements to be considered a LMI community.

NEW BUSINESS:

A. Clemens Nelson Contract

Council was advised that the automatic renewal of the Clemens Nelson contract for the retainer renews on June first. If council wishes to dissolve the contract they need to give a 60 day notice prior to the renewal date.

B. Blanket Purchase Orders

Council was provided with a list of the blanket purchase orders for various vendors that will be used throughout the year.

C. Council Rules

Mayor Reames proposed that council rules be changed to reflect the following:

- That any regularly scheduled meeting of council that falls on a village recognized holiday, automatically falls to the following day.
- That the standing committees be changed to reflect those that were proposed in the drafted council rules presented in August 2015.

Council wished to have more time to review the proposed changes before making any amendments.

Mr. John Huffman made a motion to adopt the current version of the council rules until council has reviewed the proposed changes. Mr. Dave Wallace seconded the motion.

Mayor Reames closed the nominations. Mr. Weidner passed out ballots for the election.

The results of the vote: *Mr. John Huffman – 4 votes*; *Mr. Dave Wallace – 2 votes*.

Mr. John Huffman was declared President Pro-Tem for 2017.
