## **HOLD HARMLESS RELEASE FORM**

Release. By the signature appearing below, and in consideration of the acceptance of my child's application for entry in the Little Miss & Mr. Englewood Pioneer Days Pageant, I, the undersigned parent/guardian, of the above named contestant, do hereby agree and consent to the use of any photo of said contestant in all publicity, brochures, publications, TV, etc. that the Miss & Mr. Englewood Pageant may desire. I/we hereby waive, release, and discharge any and all claims for injury or damage, whether personal or to property, which I/we may have or which may hereafter occur to me/us against the Englewood Pioneer Days Events, Lemon Bay High School Performing Arts Center, the parade float, driver and company who owns the float, parade marshal and/or the persons or entities organizing and acting in concert with them in connection with the Englewood Pioneer Days Parade and Pageant ("Parade & Pageant Committees") as a result of my/our participation in said event.

Assumption of risk. I/We understand that accidents occasionally occur during parades/events and that participants and spectators in such occasionally sustain personal injuries or property damage as a consequence thereof. Knowing the risks, nevertheless, I/we hereby agree to assume those risks and to release and hold harmless all of the Parade & Pageant Committees who, through negligence or carelessness, might otherwise be liable to me/us.

**Indemnification.** I/We further agree to indemnify, defend, and hold the Parade & Pageant Committees, their directors, officers, employees, volunteers and agents, harmless from and defend any action brought against them with respect to any claim, demand, cause of action, debt or liability, to the extent that the same, if meritorious, arises out of the negligence or willful misconduct on my/our part. <u>Must be signed to validate</u> entry!
