RELEASE, WAIVER AND INDEMNIFICATION

The undersigned participant does (do) hereby execute this release, waiver and indemnification for himself (herself/themselves), and his (her/their) heirs, successors, representatives and assigns, and hereby agree(s) and represent(s) as follows: To release the Great Northern Ride, its members, employees, volunteers, representatives and those governmental agencies and other organizations affiliated with this event from any and all liability, loss, damage, costs, claims and/or causes of action, including but not limited to all bodily injuries and property damage arising out of participating in the course referred to above, it being specifically understood that said course includes the operation and use by the undersigned participant and others of Snowmobiles. The undersigned further agree(s) to indemnify the Great Northern Ride, its employees, members, volunteers, representatives and those governmental agencies and other organizations affiliated with this event, and hold them harmless for any liability, loss damage, cost, claim or judgment or settlement which may be brought or entered against them as a result of the undersigned's participation in said course. This indemnification shall include attorney's fees incurred in defending against any claim or judgment and incurred in negotiation any settlement. It is understood and agreed that the undersigned shall have the opportunity to consent to any such settlement, provided however, that such consent shall not be unreasonably withheld.

I agree:

(1) That, whether I am a passenger on a Snowmobile or I operate a Snowmobile, there is a risk of serious injury or death. Some of the risks include loss of control, rollover, and collisions with natural and man-made obstacles, both visible and unseen. Examples of conditions that create the risk of loss of control, rollovers or collisions include variations in surface and subsurface, weather conditions, variations in terrain, trees, logs, stumps, rocks, and other forms of forest growth and debris, bumps, ditches, culverts, barriers, bridges, and fences. Also, there is a risk of collision with other persons or vehicles, and a risk of accidents caused by the negligence of fellow Great Northern Riders or other persons.

(2) To accept all risks arising out of relating to my participation of renting a snowmobile or on the guided Snowmobile tour, whether listed in paragraph (1) above or not.

(3) To abide by all federal, local, and provincial laws, rules, instructions and directions of Great Northern Ride organizers regarding participation in a Snowmobile tour. If I do not obey, Great Northern Ride may discontinue my participation in the rental/tour, without refunding any amount paid by me.

(4) To waive my right to bring any claims against Lansdowne Children's Centre or the Rotary Club of Brantford that arise out of or relate to my participation in the Great Northern Ride and to release Lansdowne Children's Centre or the Rotary Club of Brantford from liability for any such claims. This waiver and release includes claims based upon negligence by Lansdowne Children's Centre or the Rotary Club of Brantford. I further agree that I will indemnify, hold harmless, and reimburse Lansdowne Children's Centre or the Rotary Club of Brantford for all losses (including attorneys' fees and costs) from any claims brought by any persons or entities arising out of or relating to my participation in the Great Northern Ride.
