The Iowa County Landfill accepts yard waste. Do not put yard waste in your normal garbage!! There is a separate area for compost, and what can be dumped is the same as the South dump.

Lumber, and other building material, is absolutely **NOT** permitted.

Jeck and his fellow vets and their companions will be flying to Washington DC for a VIP tour of the war memorials and veterans memorials built in their honor. This will be a full, action packed day for all the veterans and an emotional one at that, as the Honor Flight program volunteers explain.

Part of the flight is the "mail call" which happens on the plane on the way home. A packet of letters to each veterans is given to them so that they can read them as they travel or when they get back home.

Antidegradation Review for Whirlpool Corporation – Amana Appliance Division in Amana, Iowa
Notice Date: August 31, 2023

Notice is hereby given that Whirlpool Corporation – Amana Appliance Division (Whirlpool) has completed a draft antidegradation review for use of alternate water treatment chemicals in the facility's industrial wastewater treatment system. Treated metal finishing process wastewater from powder coat metal preparation parts washing discharges through Outfall 003 to Unnamed Creek #2, which flows to Unnamed Creek #1, which flows to Unnamed Creek #3, which flows to the Iowa River. Unnamed Creek #2 is designated as general use, and Unnamed Creek #1 and Unnamed Creek #3 are protected for secondary contact recreation (Class A2) and warm water wildlife and aquatic life (Class B[WW-2]) beneficial uses. The Iowa River is protected for primary contact recreational (Class A1), warm water wildlife and aquatic life (Class B[WW-1]), and human health (Class HH) beneficial uses from the Unnamed Creek #3 confluence to the mouth of the Iowa River at the Mississippi River. The Iowa River is a raw water source of potable water (Class C designation) for the University of Iowa and the city of Iowa City.

The review includes the following:

- Determination of projected impacts to existing water quality,
- Findings from an alternatives analysis for use of the proposed alternate water treatment chemicals, and
- Conclusion of any social and economic evaluation of the proposed activity.

Individuals wishing to comment on use of the proposed alternate water treatment chemicals must do so in writing within 30 days of the date shown at the top of this notice. Copies of this notice and the draft antidegradation alternatives analyses are on file and available for public inspection from 8:00 am to 4:30 pm Monday through Friday at Whirlpool Corporation – Amana Appliance Division; 2800 220th Trail; Amana, IA 52204. Whirlpool will submit a summary of comments received and associated responses to the Iowa Department of Natural Resources (IDNR) with the final antidegradation review subject to IDNR review and approval.

VOTER REGISTRATION INFORMATION

Pre-registered voter registration deadline is Monday, September 18, 2023 for this election. Pre-registered voters are required to provide an approved form of identification at the polling place before receiving and casting a regular ballot. Voters who are not pre-registered – such as voters registering to vote on election day – and voters changing precincts must also provide proof of residence. A voter who is unable to provide an approved form of identification (or prove residence if required) 1) may have the voter's identity/residence attested to by another registered voter in the precinct, 2) prove identity and residence using Election Day Registration documents, or 3) cast a provisional ballot and provide proof of identity/residence at the county auditor's office by Noon on Thursday October 5, 2023. Election Day Registrant attestors must provide an approved form of identification. Voters are still encouraged to register by September 18, 2023 in the auditor's office if your residence has changed.
