Lucky Dog shall not be liable for any injury, loss or damage, as an example but not limited to: injury, loss, or claims for damages arising from fire, theft, disease, death, or the escape and/or injury of any pet which occurs while any pet is under the care and/or possession of Lucky Dog.

Lucky Dog shall not be liable for injury or harm to any pet owner or other person(s) while they are on Lucky Dog Pet Resorts, Inc. premises. All persons entering the property do so at their own risk. The undersigned acknowledges and agrees that by executing this agreement, the undersigned voluntarily assumes all such risks previously listed. All pet owners are absolutely responsible to advise Lucky Dog Pet Resorts, Inc.'s staff if their pet has social problems. Pets that exhibit aggressive behavior while boarding may be segregated and/or isolated and will not have the privileges of Lucky Dog Pet Resorts, Inc. social group play times and/or be able to leave their designated run. Pets will remain in their run and will have to be removed by the owner.

By signing this release of liability, the owner acknowledges and agrees that all pets, irrespective of their training and usual past behavior or characteristics, may act or react unpredictably at times based upon instinct or any variety of circumstances. The undersigned further recognizes that although Lucky Dog Pet Resorts, Inc. cleans and disinfects their facility regularly, any pet on premises is capable of coming in contact with a life threatening disease, virus and or natural agent, which could include as an example but not limited to: Bordetella, Parvo, Distemper, Giardia, Dust, Allergies, Flea bites, Bee stings or any other forms of communicable diseases or pests which can be transferred as a result of pet-to-pet contact, sharing water bowls, exercise yards and pet enclosures.

I hereby acknowledge and agree that I am assuming all of the risk and financial responsibility associated with the death or illness of, or any injury to, my pet(s) arising from its services provided at Lucky Dog Pet Resorts, Inc. Should my pet require medical attention the Lucky Dog Pet Resorts, Inc. personnel have the right, but not the obligation, to seek medical advice and treatment. 1. I, \_\_\_\_\_, the undersigned (“Owner”) understand and agree that by allowing my pet(s) to enter Lucky Dog Pet Resorts, Inc. (“Lucky Dog”), Lucky Dog staff is relying upon me to inform them of any physical or health issues involving my pet, and that otherwise this release and waiver shall be relied upon by Lucky Dog as my representation that my pet(s) is/are in good health and has/have not harmed or shown aggressive or threatening behavior that has not been disclosed towards any person or any other pet or pet species. The Lucky Dog staff may at any time remove any pet, including mine, from a yard if he/she exhibits behavior which could be harmful to other pets or staff. If my pet exhibits aggressive behavior while boarding my pet may be segregated and/or isolated and/or will not be able to leave their designated run. My pet(s) will remain in their run and I will have to remove my pet from their designated run. \_\_\_\_\_

2. Owner further understands and agrees that pets will sometimes receive cuts, bites and scratches while in a play yard and Lucky Dog shall not be held liable or responsible for any such conditions whatsoever. \_\_\_\_\_

3. I have read and understand the conditions and statements of this agreement, including the following: All dog(s) must have current and up-to-date on DHLPP, Rabies, and Bordetella vaccinations in order to attend Lucky Dog for any service and **I am responsible for keeping Lucky Dog supplied with up to date records.** \_\_\_\_\_

4. I understand there is always a risk that my pet(s) will contract Canine Cough or Canine Flu even if they are up to date on their Bordetella vaccine and/or Flu Vaccine during their stay at Lucky Dog. Bordetella/Canine cough is an extremely contagious upper respiratory virus, and even in the most hygienic, well ventilated, spacious kennels the possibility of a dog acquiring Bordetella/Canine Cough still exists, and Lucky Dog is not responsible for any pet displaying symptoms or having been diagnosed with Bordetella/Canine Cough during or following their visit or stay at Lucky Dog. \_\_\_\_\_

5. If I arrive after 5:00 p.m. to pick up my pet(s), I will not be able to pick my pet(s) up until the following day and I will be charged, and pay, for an additional night of boarding. \_\_\_\_\_

6. I understand that if I drop my pet(s) off after 4pm for boarding I will be charged a late drop off fee of \$15. If I drop off after 4pm, I understand that I need to have my pet(s) fed and medicated for the night. \_\_\_\_\_

7. I understand that if I leave my pet(s) in a late pick up kennel after 7pm my pet(s) will be boarded and I will be charged a non-reservation boarding fee of \$45 plus the daycare fee for that day.. \_\_\_\_\_

8. I understand that for my safety, the safety of my pet(s), and the safety of other pet(s) and owners, that I will leave my pet(s) in the car while I check them in. I will never bring them through the front gates or office until instructed by a staff member to do so. \_\_\_\_\_

9. I understand that if I bring my pet in for a groom/bath, and their coat is matted and/or they have an unusually thick undercoat, they are at a greater risk of injury, stress, or trauma. I also acknowledge that problems occasionally arise, during or after grooming, such as but not limited to: nicks, clipper irritation and mental or physical stress. The condition of my pet(s) coat and/or stress level may affect what Lucky Dog can do during their appointment (for example: if a dog’s coat is matted, stress levels are too high or pet(s) becomes aggressive we may not be able to brush them out properly during a scheduled bath). \_\_\_\_\_
