## Getting Your Affairs in Order

Our February Zoom Luncheon speaker was Robert (Bob) Valentine, a fellow member of PEP, and a wellrespected attorney whose practice is in Manhattan Beach. His specialty is in assisting clients with their estate planning and will and trust documents, which are especially important for those who have accumulated assets such as real estate, savings, retirement accounts, IRAs, insurance, and other investments over the

course of their lives. Having your affairs in order allows you to control the distribution of your assets after you pass.

Bob made us aware of changes in California laws that take effect at age 65. One is Proposition 19, which strips away many Proposition 13 and 58 benefits to families, especially regarding the transfer of property from parents to their children in Prop. 58.

When developing a trust, the trustee selects a "successor trustee/executor" who will assume control of the assets within the trust to pay outstanding bills, sell property per the trust instructions, dispose of goods, etc. upon the passing of the trustee. It's a major responsibility, hence the importance of who is named "executor" of the trust.

Be mindful of changes in laws and review your trust documents. Meet with your attorney to be sure your trust is up to date. Currently up to \$11,700,000 in assets per person can be passed to heirs (\$23.4 million for a married couple) before an inheritance tax is levied. This is reduced by 50% when the law expires on Dec. 31, 2025. According to Bob, the current federal administration is in discussion about changes in capital gains taxes. Hence, property owners be aware.

You need to consider how to inform the successor trustee of your accounts (banks, investments, credit cards, safe deposit box, etc.) and on-line passwords. There are on-line sites offering secure storage of passwords. Instructions to the executor can be left on a personal computer and/ or an external hard drive, which can be kept in a safe deposit box.

Bob shared some experiences faced by a few families which illustrated the importance of careful planning for how you want your assets distributed and who you want to name as your executor. Go to the PEP website to view his presentation.

being administered by many, many different outlets.


