FEATHERS IN THE WIND

It was the spring of 1956 and the end of school was soon approaching. The annual picnic would be held in the ball park and then the dreaded report cards handed out determining one's fate for the coming school year.

Needless to say we were all anxious as to whether or not we would be allowed to pass to the next level-fourth grade. Looking back on that miserable day our parents would have known where we stood, but because they wanted us to be well behaved never said a word.

We all were promoted, but word had gotten out a new teacher was going to appear on the horizon.

I had adored my third grade teacher and frankly was not looking forward to fourth grade and learning about fractions. Now I heard about this new teacher. A new school year did not look promising.

Then the "bomb" dropped. The new teacher was a man! This was unacceptable in my mind. All elementary teachers were supposed to be women. Wasn't there some kind of law about that? My mother would remind that my grandpa had taught upper elementary children, but he was strict and I was having none of this. Perhaps if I spoke to my beloved Uncle Carl he would understand.

That didn't work nor did my many "illnesses" work. Finally Tante Mildred Meyer told mommy about this a male teacher' and I consented to give it a try.

This would be Mr. Berger's first class and we had a "reputation." I suppose the signs of relief has we left from one class to another gave us away.

The fourth and final installment of Honoring Our WWII Colony Veterans, by Emilie Hoppe

News from the Pacific and European theaters grew sobering. The Amana Bulletin issue dated Jan. 21, 1943, published a letter from Ernest Bahndorf, East Amana, who wrote from England, "I also had my turn to go out on the (location/ task was censored). I had my experience shooting them, but it takes a man to shoot them. . . I don't think that there is a man that went through all the things I did so far, except those fellows that are overseas, but not those that are still back in the States. And they won't see it either until they get on the boat."

Still the young men tried to keep up spirits at home. Private William Zierold, South Amana, wrote from an icy north Pacific bivouac, "What is the Amana soldier fighting for? He is fighting not only for his own existence, but for his loved ones, his love for freedom, for those generations yet unborn. Our aim is to make Americanism honored and respected throughout the world."

West Amana Soldier Roy Ehrmann wrote to family of his experiences helping to build the Alaskan highway. He and his unit of engineers and "grunts" built the road from Dawson Creek, BC through the Yukon to Delta Junction, Alaska. The goal was for the road to carry supplies to and from bases in Alaska for the Pacific theatre.

And like all soldiers everywhere, the Amana soldiers paid with blood. The list is long of wounded colony boys includes Kenny Schafer, East Amana, a member of the 3rd Army, 44th Armored Infantry. He was seriously wounded in battle in Germany in April 1945 and spent nine months in hospitals, earning a Purple Heart.

Louis Marz, who also served with the 3rd Army was wounded in April of 1945. He too spent time in hospital and earned a Purple Heart.

George Ehrman, awarded three bronze battle stars serving in the Battle of the Bulge in the Ardennes Forest, was seriously injured there. The Battle of the Bulge was the last major offensive of the German Army in WW2 and lasted five weeks from December 16 through January 28, 1945.

Sergeant Dean Hawkes was wounded in the invasion of France and was hospitalized in France, England and America. No date, nor details was reported in the ASI Bulletin only the news that he was coming home after having been wounded in France.

Elmer Baumgartel was wounded and hospitalized in France and then eventually shipped home.

Though again the details were not included, on April 15, 1945 it was reported in the Bulletin that Orville Oehler had earned the Purple Heart for wounds sustained sometime during that bloody winter and spring.

Edward Fritsche's unit was stranded on an occupied South Pacific island so long that they ran out of supplies. Most of his unit fell ill and died of starvation, malaria and dysentery. When the Amana youth returned after more than two years few recognized him. He married his childhood sweetheart Marie "Mia" Flick and they honeymooned in Washington

We were like a group of cats with rabies. No one could control us. Each of us had very different personality which we felt should be HEARD,

The poor man was doomed, but he brought so many good memories. One was the interesting bulletin boards which some of us who would become Teacher ourselves would duplicate. He brought a story-time reading to us from books like Robinson Crusoe to us after lunch. Books we were too young to read by ourselves, but old enough to understand and have read to us. At Christmas each of us got a neat wrapped puzzle. He started to teach us how to draw - really draw.

Finally came the most wonderful thrill of all June 15, 1957. We all got invitations to his wedding in Cedar Rapids no less.

I remember going with a friend and her mother and wearing my special gloves and hat. Imagine seeing your teacher, a person you had seen every day all school year getting married! It was unbelievable and my friend I could hardly sit still.

Weeks later we would bet a "thank you card" from Mr. and Mrs. Berger for the gift we (my parents) had sent AND a picture of the couple in their wedding finery. Most of us girl would put that picture in our wallets and keep it for years. A large portrait of them would hang at the photographers showroom in "Pride of place" for a long time and many of us would go and point to it later when we would have our graduation or wedding portraits done.

Looking back on all those years I still wonder if I would have been so afraid. Probably because I am basically a shy person and dislike change.

DC where he had been assigned following his return to the states.

Staff Sergeant Jack Zimpleman, a gunner on a B-24 Liberator based in England, was awarded the Oak Leaf cluster in March 1945. On April 9 his plane was shot down over Germany and he was "reported missing over Germany." Somehow he managed to survive, escape across enemy lines and make his way to England with help from the allied underground. He came home to High Amana on leave a couple of months later, before returning to England where yes, he flew missions again.

On September 19, 1943 Otto Solbrig, East Amana, was reported missing during the Allied invasion of Italy where he had been captured by the Germans. Later he told friends that he had overheard his German captors coolly debating whether or not they should shoot him on the spot. For the duration of his 18 month-internment in a German POW camp, Solbrig hid the fact that he could speak German, both because he knew he would be shot as a spy and because the knowledge he gained from the guards who didn't suspect he understood their conversations was often useful.

While believing that their son Otto was missing in Europe, Otto's parents, William and Louise, learned that their 19-year-old son, Oswald, had been killed April 7, 1945 at Okinawa. His memorial service was held in the Amana Church on a beautiful May afternoon. A week or so later, another telegram arrived in East Amana with the news that Otto had been found alive and was on his way home.

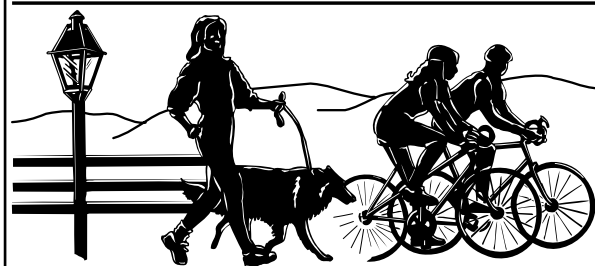

CHAPTER 31.40 SHORT-TERM RENTAL OF GUEST ACCOMMODATIONS

Section 31.40.010 Definitions and Interpretations

Words and meanings set forth in this ordinance shall have the meanings set forth in this section. Words and phrases not defined in this section but already defined in the zoning ordinances of the ACLUD shall be given the meanings set forth in such ordinances. All other words and phrases shall be given their common, ordinary meaning, unless the context clearly requires otherwise.

- **Agricultural Area.** Refers to ACOS, ACOS-NA and HP-A districts and sub-districts.
- **Building.** Principal and accessory buildings on a property.
- **Commercial Area. Refers to C-1, C-2, C-3 and HP-C districts and sub-districts.**
- **Dwelling.** Any stationary, permanent building, or portion thereof, which is designed or used exclusively for residential purposes.
- **Residential Area.** Refers to R-1, R-2, R-3 and HP-R districts and sub-districts.
- **Short-Term Rental (STR).** A guest accommodation, not meeting the definition of a Bed and Breakfast Establishment or Hotel/Motel, where, in exchange for compensation, a dwelling is provided for lodging for a period of time not to exceed thirty (30) consecutive days.
- **Short-Term Rental Owner.** The owner of record of the property.

Section 31.40.020 Short-Term Rental Parameters

The Short-Term Rental Owner, or a person or organization designated by the owner, shall be available for and responsive to contact at all times. The STR Permit document shall be posted on an interior wall next to the primary entrance of the dwelling being rented, and 24/7 contact information shall be available for viewing at any time at this location.

The Short-Term Rental Owner, or a person or organization designated by the owner, must have their permanent residence or place of business located within a 50-mile radius of the property being used for STR.

No entity shall operate a Short-Term Rental without first having obtained a STR Permit.

Change of Use Permits shall apply to a particular property.

No person or immediate family, individually or as part of a corporation, may hold more than quantity two (2) STR Permits at any given time. Permits are assigned to a specific property. Permits are transferable through the use of a Short-Term Rental of Guest Accommodations Transfer Application form. The transfer process requires re-application and re-evaluation by ACLUD as well as up to date permit fees.

A minimum of forty per cent (40%) of the total STR permits made available will be reserved for individuals who are permanent residents within the Land Use District.

Buildings with approved STR Permits shall be limited to no more than three (3) separate dwellings within them. Parking shall be made available on-site at a rate of one (1) parking space for each bedroom located in each dwelling.

Section 31.40.030 Permit Availability

A maximum quantity of twenty (20) active STR permits are to be issued within the boundaries of the Amana Colonies Land Use District. No more than seven (7) permits may be issued per village.

Section 31.40.040 STR Permit Application and Approval

Each applicant for a STR Permit will pay an initial, non-refundable permit application fee, even if the permit is not granted. There shall also be an additional fee charged for each additional rental dwelling within a building up to the maximum of three (3) allowed. The current permit application fees shall be stated on the Short-Term Rental Guest Accommodations Permit Application form.

There will be an approval process in place for each individual permit application. The ACLUD Board of Trustees, at their discretion, may either perform this review process themselves, or delegate approval authority to the Land Use Administrator or a designated review committee. Only upon successful completion of this review will an applicant be granted an active STR Permit.

Section 31.40.050 STR Permit Renewal and Approval

Any STR Permit holder who wishes to renew their permit for another year shall submit the renewal within sixty (60) days of expiration. Renewals will require a non-refundable permit renewal fee, even if the renewal of the permit is not granted. There shall also be an additional renewal fee charged for each additional rental dwelling within a building up to the maximum of three (3) allowed. The current permit renewal fees shall be stated on the Short-Term Rental Guest Accommodations Permit Renewal form.

There will be an approval process in place for each individual permit renewal. The ACLUD Board of Trustees, at their discretion, may either perform this review process themselves, or delegate approval authority to the Land Use Administrator or a designated review committee. Only upon successful completion of this review will an individual be granted a STR Permit renewal.

Section 31.40.060 Penalties and Enforcement

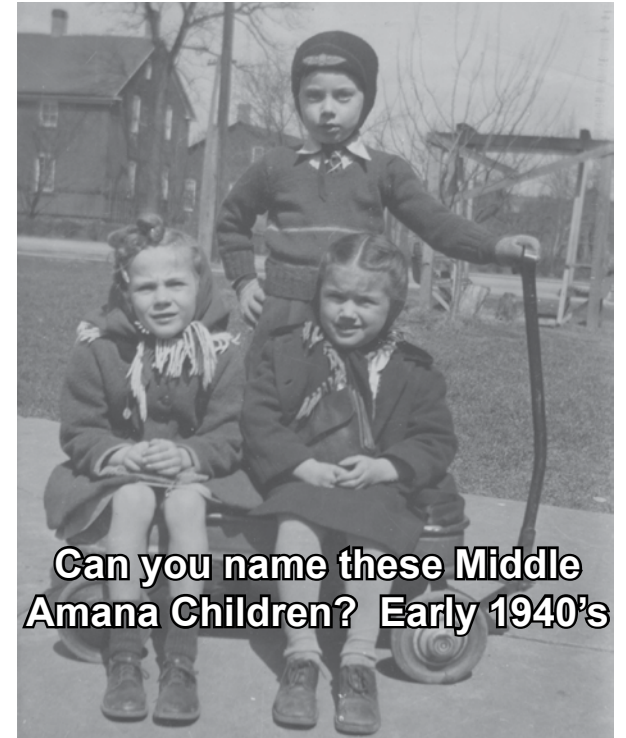
Any person or entity operating a Short-Term Rental without an active STR Permit, after receiving notice of violation and notice of the permit requirements, shall cease all rentals until an STR Permit has been granted. Failure to comply will result, at the discretion of the ACLUD Board of Trustees, in a fine being levied against said person or entity as stated in the notice and as allowed by the ACLUD ordinances.

It is the responsibility of the Short-Term Rental Owner, or a person or organization designated by the owner, to operate and maintain their STR dwelling(s) in a safe and effective manner. All premises under an STR Permit shall be in compliance with all applicable laws and regulations, including basic uniform building and electric codes adopted by the State of Iowa and other local jurisdictions. The ACLUD may adopt policies requiring inspection and other reasonable means of proving fitness of habitability and compliance of STR dwelling(s). Failure to comply may result in revocation of an active STR Permit.
