ARTICLES OF INCORPORATION

OF

ARLINGTON WOODS PROPERTY OWNERS ASSOCIATION

The undersigned, a majority of whom are citizens of the United States, desiring to form a non-profit corporation under the non-profit laws of the State of Ohio, do hereby certify; 361

FIRST: The name of said corporation shall be ARLINGTON WOODS PROPERTY OWNERS ASSOCIATION.

SECOND: The place in this state where the principal office of the corporation is to be located is the Township of Liberty, Wood County, Ohio.

THIRD: The purpose or purposes for which said corporation is formed are:

a) To receive and accept the assignment, transfer and conveyance to it from Arlington Woods Development Corporation or from any transferee from said corporation or successor in title to said corporation; of all title, right and interest which said corporation may have in all park areas, playgrounds, parkways, private thoroughfares, and recreational facilities now located in or to be constructed on any part of Arlington Woods, a subdivision in Liberty Township, Wood County, Ohio, or on land adjacent thereto or in the vicinity thereof now owned by said corporation; and any other property now owned by Arlington Woods Development Corporation in said township.

b) To exercise such of said rights, duties, powers and obligations as may from time to time be assigned, transferred and conveyed or acquired by it, including but not excluding others, the right to abate nuisances; to permit the use of any of the aforesaid parks, playgrounds, parkways, private thoroughfares and recreational facilities by others; to collect maintenance charges and emergency charges, which are now charged against certain lots in Arlington Woods, a subdivision in Liberty Township, Wood County, Ohio, or in any additional plat or plats of said subdivision, in the event the owner of record title to lots in such additional plat or plats become members of Arlington Woods Property Owners Association, as hereinafter provided for, or may become subject to such charges by the recorded restrictions placed against them; to enforce any of said recorded restrictions; to accept contributions for the construction and maintenance of any of said parks, playgrounds, parkways, private thoroughfares and recreational facilities; and to direct the expenditure of any of the aforementioned funds; all of the foregoing to be for the benedit of the members hereof, but not for profit.

To do any and all other things necessary or C) desirable to maintain or improve the aforesaid facilities and which may be incident thereto, but not for profit.

d) To do any and all other things, not for profit, and not prohibited by law, to enhance the welfare of the community composed of the owners of lots in Arlington Woods and the owners of lots in any additional plats of Arlington Woods created by the subdivision of land in said township now owned by Arlington Woods Development Corporation in the event the owners of any such lots become members of this association.

e) To purchase, or otherwise acquire, lease as lessee, invest in, hold, use, lease as lessor, encumber, sell, exchange, transfer, and dispose of property of any descrip-tion or any interest therein, by authority and action of its board of trustees.

f) To borrow money, and issue, sell, and pledge its notes, bonds, and other evidences of indebtedness, and to secure any of its obligations by mortgage, pledge, or deed of trust of all or any of its property, by authority and action of its board of trustees.
