Please check (and sign-up with) www.arapalert.com, a notification system about all natural or man-caused disasters in the Arapahoe county.

# Friendly Reminders

Our covenants require an ACR (Architectural Change Request - available on the website) form to be completed and approved by the Architectural Committee Chair, prior to the work being done.

- 15 days prior to the start date for minor changes such as painting, roofing, minor landscaping, siding, windows, rear decks and patios, etc.
- 45 days prior to start date for major changes in landscaping, exterior additions, and large concrete projects (sidewalks, driveways, etc.).

If these deadlines are not met, the board cannot guarantee your request will meet your expected start date, and under no circumstances can your project begin without written approval.

Also, and per the Aurora city code, you cannot blow leaves in the streets & gutters, and you must shovel your sidewalks within 24 hours of a snowfall.

Lastly, solicitation is not permitted in Andover Glen, whether or not you are a homeowner.
