Pre-entries must be received **by November 30, 2019**, at the event secretary's address.

Pre-entries are **\$20.00** for the first run and **\$17.00** for 2nd run for the **same dog in the same trial**. Discount example. AG1 and AG2 same dog same trial. If you are entering AG1 each trial would be \$40.00. If you are entering AG1 and AG2 each trial, would be \$20 plus \$17 each trial.

Weekend **GRACH Special: \$50.00-All 3 Levels** for the **same dog/same trial - Pre-Entry Only**.

**Junior Handler entries are \$12.00 Day of Show JR \$15.00**

*Entries will run in "B" if no designation in indicated.*
