Sick Child Policy

We understand the need for connection and socialization with other parents and children and how difficult it may be to stay home with a sick child. Our priority here at Encouraging Kids is to maintain a safe, healthy, nurturing environment for everyone. To accomplish this we **must** insist that you keep your child home if he/she has **any** of the following:

<u>Fever</u>, irritability, lethargy, persistent crying, or difficulty breathing - can be signs of illness.

An upper respiratory illness, such as bronchiolitis or influenza.

The common cold with coughing, sneezing, runny nose.

<u>Diarrhea</u>, <u>Vomiting</u>, <u>Bloody stools</u> or stools containing mucus. These could be the sign of a viral or bacterial infection. (Give your doctor a call!)

<u>Rash.</u> This is reason to keep your child home unless you know for sure that it's *not* linked to an infection (for example, if you know it's a reaction to eating strawberries).

<u>Chicken pox</u>. Child is no longer contagious once all the sores have dried and crusted over.

Impetigo. Kids with this skin disease are no longer contagious after 24 hours of antibiotics.

<u>Scabies.</u> Once treated with a topical insecticide, it's no longer contagious.

Bacterial conjunctivitis (pinkeye) and yellow discharge from the eye.

Strep throat. It's usually not contagious after 24 hours of antibiotics.

Mouth sores that cause excessive drooling. Wait until your doctor says they're not infectious

<u>Head lice</u>. Your child can return after he or she has been thoroughly treated.

Any other contagious diseases or illnesses not listed above.

We can all work together to keep our children as healthy as possible. If any parent or guardian continually violates this sick policy, they will unfortunately forfeit their membership without refund.
