In 1992 Bethany Baptist Church engaged Development Outreach, Inc. to be a part of the development team to construct the first senior housing project, a seven (7) story, 77 unit Section 202 HUD financed facility aptly named, "Henry Brooks Senior Housing". In conjunction with that project, in 1997, Development Outreach co-sponsored with Bethany Baptist Church once again to construct a second Section 202 HUD financed facility, a 57 unit housing facility named "Mt. Morris Plaza Senior Housing"

Today, with development opportunities arising, DOI is seeking to explore building Senior Housing in its affiliate city, Hattiesburg, Mississippi as the company has been licensed by the state to conduct business.

Development Outreach, Inc. is excited to bringing a better quality of life to Mississippi and its senior citizens as it has done in the Greater, New York Community.

Development Outreach, Inc., a not-for profit, 501 (c)(3) corporation, located at 270 Lenox Avenue, New York, NY, specializes in providing housing and services to low-moderate income singles families with children and the elderly since 1977. Development Outreach, Inc., provides Housing Consulting Services, Real Estate

Management Services, 7A Administration, and under the auspices of its President, Development Outreach, Inc., is duly licensed to transact business as a Real Estate Brokerage Company. Our community services include co-sponsorship of Section 202 Supportive Housing for the Elderly, Nutrition programs for the Elderly, Social activities for the Elderly, Youth Mentorship Programs, Health and Wellness programs, After-school programs, HUD Neighborhood Network sites, and Intergenerational Programs.

HUD Section 202 Supportive Housing for the Elderly

Our commitment to senior services includes the sponsorship and management of Section 202 Supportive housing. Currently we provide a full range of services for the management, maintenance and operation of 134 units of Section 202 housing for the elderly, which serves approximately 160 seniors. In 1992 we were selected by Bethany Baptist Church as part of their development team for the construction of Henry Brooks Senior Housing. This HUD financed Section 202 Supportive Housing Project for the Elderly of 77 units, which we presently manage, opened for occupancy in July of 1994. The 7 story site consists of (76) + (1) units; (19) studios and (57) one bedroom units, (8) of which are handicap accessible. In its most recent REAC physical inspection (2011) Henry Brooks Senior Housing project earned a score of 98% with no exigent deficiencies.

In 1997, Development Outreach, Inc., co-sponsored with Bethany Baptist Church the acquisition, development and construction of Bethany /Development Outreach Mt. Morris Plaza Senior Housing project, a HUD Section 202 Supportive Housing Project of 57 units, which we presently manage, opened for occupancy in December of 2003. In its most recent REAC physical inspection (2010) Bethany/Development Outreach Mt. Morris Plaza Senior Housing project earned a score of 99% with no exigent deficiencies.

Both facilities are beautifully maintained and serve as models of Development Outreach's commitment to a better quality of life for the elderly.
