a. Update on current Grievance

We continue to assert that the child rearing leave section of the contract supersedes the 90 day requirement. Contract language does not support needing the 90 days. Plus we also contend that the sick leave days taken for maternity should be counted as days (since the state counts them as days toward pension)- but the district disagrees. This issue also applies to Military leave as well.

We are in the process of writing and preparing a grievance for this issue.

a. Building Leaders got a print out of names to review for accuracy. Letters with membership forms were sent to all those on the list who are marked as FEE.

VIII. Building Level Reports
